The A48 Trunk Road (Cross Hands  
Roundabout to South-East of  
Pensarn Roundabout) and the A40  
Trunk Road (Pensarn Roundabout  
to St Clears Roundabout,  
Carmarthenshire) (Temporary  
Traffic Restrictions and  
Prohibitions) Order 2015

*Made* 3 September 2015

*Coming into force* 14 September 2015

The Welsh Ministers, being the traffic authority for the relevant lengths of the London – Fishguard Trunk Roads (A48 and A40) (“the trunk roads”), are satisfied that traffic in specified lengths of the trunk roads should be restricted and prohibited because of works proposed on or near the roads.

The Welsh Ministers, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

**Title, Interpretation and Commencement**

**1.** This Order comes into force on 14 September 2015. Its title is The A48 Trunk Road (Cross Hands Roundabout to South-East of Pensarn Roundabout) and the A40 Trunk Road (Pensarn Roundabout to St Clears Roundabout, Carmarthenshire) (Temporary Traffic Restrictions and Prohibitions) Order 2015.

**2.** —(1) In this Order:

“exempted vehicle” (“*cerbyd esempt*”) means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

“the lengths of the trunk roads” (“*y darnau o’r cefnffyrdd*”) means the lengths of the trunk roads, in the County of Carmarthenshire, specified in the Schedules to this Order;

“works period,” (“*cyfnod y gwaith*”) means intermittent periods commencing at 00.01 hours on 14 September 2015 and ending when the temporary traffic signs for each period of works are removed.

(2) Any reference in this Order to a numbered article or Schedule is a reference to the article or Schedule bearing that number in this Order.

### **Restrictions and Prohibitions**

**3.** Subject to the provisions of article 9, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour, in the lengths of the trunk roads specified in Schedule 2.

**4.** Subject to the provisions of article 9, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour, in the lengths of the trunk roads specified in Schedules 1 and 2.

**5.** Subject to the provisions of article 9, no person shall, during the works period, use or permit the use of a vehicle, other than an exempted vehicle, in such a way that it overtakes any other vehicle in the lengths of the trunk roads specified in Schedules 1 and 2 during such times as the restriction referred to in article 4 is in force.

**6.** Subject to the provisions of article 9, no person shall, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed in the length of the trunk road specified in Schedule 3.

**7.** Subject to the provisions of article 9, no person shall use or permit any vehicle, other than an exempted vehicle, to make a right hand turn in the lengths of the trunk road specified in Schedule 4.

### **Suspensions**

**8.** The provisions of The A40 Trunk Road (Meidrim Junction, Carmarthenshire) (De-Restriction) Order 2004(**3**), The A48 Trunk Road (Porthyrhyd Junction, Carmarthenshire) (De-Restriction) Order 2005(**4**), The A40/A48 Trunk Roads (Pensarn Roundabout, Carmarthenshire) (40 mph Speed Limit) Order 2009(**5**), The Trunk Road (A48) (Foelgastell, Dyfed) (De-Restriction) Order 1990(**6**), The A40 Trunk Road (Banc-y-felin Junction, Carmarthenshire) (De-Restriction) Order 2004(**7**), The Trunk Road (St Clears, Dyfed) (40 MPH Speed Limit) Order 1982(**8**) and The A40 Trunk Road (Llangynnwr Roundabout to Pensarn Roundabout and Pensarn Roundabout to West of Pont Lesneven Roundabout, Carmarthenshire) and The A48 Trunk Road (South East of Pensarn Roundabout, Carmarthenshire) (40 and 50 MPH Speed Limits and De-restriction) Order 2015(**9**) are hereby suspended in respect of the lengths of the trunk roads specified in the Schedules to this Order during such

times as the restrictions specified in articles 3 and 4 are in operation

### **Application**

**9.** The provisions of article 3, 4, 5, 6 and 7 shall apply only during such times and to such extent as the application of the prohibition and restrictions referred to therein is indicated by traffic signs.

### **Duration of this Order**

**10.** The maximum duration for this Order shall be 18 months.

## **SCHEDULE 1**

### **TEMPORARY 10 MPH SPEED LIMIT AND PROHIBITION OF OVERTAKING**

- i) That length of the eastbound carriageway of the A48 Trunk Road that extends from its junction with Pensarn Roundabout to a point 50 metres south-east of its junction with Pensarn Roundabout.
- ii) That length of the westbound carriageway of the A48 Trunk Road that extends from a point 358 metres south-east of its junction with Pensarn Roundabout to its junction with Pensarn Roundabout.
- iii) That length of the A40 Trunk Road that extends from its junction with Pensarn Roundabout to its junction with Pont Lesneven Roundabout.
- iv) The entire lengths of the gyratory carriageways of Pont Lesneven and Pensarn Roundabouts.

## **SCHEDULE 2**

### **TEMPORARY 40 AND 10 MPH SPEED LIMITS AND PROHIBITION OF OVERTAKING**

#### **A40 TRUNK ROAD**

- i) That length of the westbound carriageway of the trunk road that extends from its junction with Pont Lesneven Roundabout to a point 116 metres east of St Clears Roundabout.
- ii) That length of the eastbound carriageway of the trunk road that extends from a point 116 metres east of St Clears Roundabout to a point 30 metres west of its junction with Pont Lesneven Roundabout
- iii) That length of the eastbound on-slip road that extends from a point 75 metres from its junction with the B4312, Llanstephan Road, to its junction with the main eastbound carriageway of the trunk road .

#### **A48 TRUNK ROAD**

- i) That length of the westbound carriageway of the trunk road that extends from a point 170 metres west of its junction with Cross Hands Roundabout to a point 358 metres south-east of its junction with Pensarn Roundabout.
- ii) That length of the eastbound carriageway of the trunk road that extends from a point 50 metres south-east of its junction with Pensarn Roundabout to a point 170 metres west of its junction with Cross Hands Roundabout.

## **SCHEDULE 3**

### **TEMPORARY PROHIBITION OF VEHICLES**

That length of the westbound carriageway of the A48 trunk road that extends from its junction with the main circulatory carriageway of Cross Hands Roundabout to its junction with the Class III road, C2085, leading to Heol-Y-Foel, Foelgastell.

## **SCHEDULE 4**

### **TEMPORARY PROHIBITION OF RIGHT HAND TURN**

- i) The right hand turn from the westbound carriageway of the A48 Trunk Road at Maes Y Bont Junction on to Class III Road, C2066.
- ii) The right hand turn from the eastbound carriageway of the A48 Trunk Road at Foelgastell Junction on to Class III Road, C2085.
