*(Nid yw'r nodyn hwn yn rhan o'r Gorchymyn)*

Y Gorchymyn hwn yw'r gorchymyn cychwyn cyntaf a wneir gan Weinidogion Cymru o dan Ddeddf Cynllunio (Cymru) 2015 ("y Ddeddf").

Mae erthygl 2 o'r Gorchymyn hwn yn dwyn adran 4 o'r Ddeddf i rym ar 5 Hydref 2015 i'r graddau nad yw'r adran honno eisoes mewn grym. O dan adran 58(2)(b) o'r Ddeddf, daeth Rhan 3 o'r Ddeddf i rym ar 6 Medi 2015 (2 fis ar ôl y dyddiad pan roddwyd y Cydsyniad Brenhinol ar 6 Gorffennaf 2015) i'r graddau y mae'n angenrheidiol i alluogi Gweinidogion Cymru i wneud rheoliadau o dan y Ddeddf.

Mae adran 4 yn ymwneud â'r broses ar gyfer dynodi ardaloedd cynllunio strategol a sefydlu paneli cynllunio strategol. Mae adran 4(1) o'r Ddeddf yn mewnosod adrannau 60D i 60G yn Rhan 6 (Cymru) o Ddeddf Cynllunio a Phrynu Gorfodol 2004 ("Deddf 2004").

Mae adran 60D o Ddeddf 2004 yn gwneud darpariaeth i Weinidogion Cymru wneud rheoliadau i ddynodi ardal gynllunio strategol ac i sefydlu panel cynllunio strategol ar gyfer yr ardal honno.

Mae adran 60E o Ddeddf 2004 yn nodi'r broses y caiff Gweinidogion Cymru ddyroddi cyfarwyddyd drwyddi i un neu ragor o awdurdodau cynllunio lleol i gyflwyno cynnig i Weinidogion Cymru ar gyfer dynodi ardal yn ardal gynllunio strategol.

Mae adran 60F o Ddeddf 2004 yn gosod dyletswydd i ymgynghori ar Weinidogion Cymru.

**EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order is the first commencement order made by the Welsh Ministers under the Planning (Wales) Act 2015 ("the Act").

Article 2 of this Order brings section 4 of the Act into force on 5 October 2015 in so far as that section is not already in force. Under section 58(2)(b) of the Act Part 3 of the Act came into force on 6 September 2015 (2 months from the date of Royal Assent, which was 6 July 2015) so far as is necessary for enabling the Welsh Ministers to make regulations under the Act.

Section 4 relates to the process for designating strategic planning areas and establishing strategic planning panels. Section 4(1) of the Act inserts sections 60D to 60G into Part 6 (Wales) of the Planning and Compulsory Purchase Act 2004 ("the 2004 Act").

Section 60D of the 2004 Act makes provision for the Welsh Ministers to make regulations to designate a strategic planning area and establish a strategic planning panel for that area.

Section 60E of the 2004 Act sets out the process by which the Welsh Ministers may issue a direction to one or more local planning authorities to submit a proposal to the Welsh Ministers for an area to be designated as a strategic planning area.

Section 60F of the 2004 Act imposes a duty to consult on Welsh Ministers.

Mae adran 60G o Ddeddf 2004 yn ei gwneud yn ofynnol i awdurdodau cynllunio lleol i ddarparu gwybodaeth i Weinidogion Cymru os cânt gais i wneud hynny.

Mae adran 4(2) o'r Ddeddf yn cyflwyno Atodlen 1 i'r Ddeddf. Mae Rhan 1 o Atodlen 1 yn mewnosod Atodlen 2A yn Neddf 2004 ac yn darparu ar gyfer trefniadau cyfansoddiadol, ariannol a gweinyddol y paneli.

Mae paragraff 28 o Atodlen 1 yn caniatáu i'r Atodlen gael ei diwygio drwy reoliadau.

Gweler adran 58 (dod i rym) o'r Ddeddf am ddarpariaethau sy'n dod i rym ar ôl pasio'r Ddeddf.

Section 60G of the 2004 Act requires local planning authorities to provide the Welsh Ministers with information if requested.

Section 4(2) of the Act introduces Schedule 1 to the Act. Part 1 of Schedule 1 inserts Schedule 2A into the 2004 Act and provides for the constitutional, financial and administrative arrangements of panels.

Paragraph 28 of Schedule 1 permits amendments to the Schedule to be made by regulations.

See section 58 (coming into force) of the Act for provisions which come into force after the passing of the Act.

**Title and interpretation**

1.—(1) Enw'r Gorchymyn hwn yw Gorchymyn Deddf Cynllunio (Cymru) 2015 (Cychwyn Rhif 1) 2015.

1.—(1) The title of this Order is the Planning (Wales) Act 2015 (Commencement No. 1) Order 2015.

(2) Yn y Gorchymyn hwn ystyr “y Ddeddf” yw Deddf Cynllunio (Cymru) 2015.

(2) In this Order “the Act” (“y Ddeddf”) means the Planning (Wales) Act 2015.

**Provisions coming into force on 5 October 2015**

2. Y diwrnod penodedig ar gyfer dwyn y darpariaethau a ganlyn o'r Ddeddf i rym, i'r graddau nad yw'r darpariaethau hynny eisoes mewn grym, yw 5 Hydref 2015—

2. The appointed day for the coming into force of the following provisions of the Act, so far as those provisions are not already in force, is 5 October 2015—

- (a) adran 4 (dynodi ardaloedd cynllunio strategol a sefydlu paneli cynllunio strategol); a
- (b) Rhan 1 o Atodlen 1 (cyfansoddiad a threfniadau ariannol paneli).

- (a) section 4 (designating strategic planning areas and establishing strategic planning panels); and
- (b) Part 1 of Schedule 1 (constitution and financial arrangements of panels).
