The A458 Trunk Road (Neuadd
Bridge to Llangadfan, Powys)
(Temporary Traffic Prohibitions and
Restrictions) Order 2015

Made 5 January 2015

Coming into force 12 January 2015

The Welsh Ministers, being the traffic authority for the relevant lengths of the Shrewsbury – Dolgellau Trunk Road (A458) (“the trunk road”), are satisfied that traffic in specified lengths of the trunk road should be prohibited and restricted because of works proposed on or near the road.

The Welsh Ministers, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

Title, Interpretation and Commencement

1. This Order comes into force on 12 January 2015. The title to this Order is The A458 Trunk Road (Neuadd Bridge to Llangadfan, Powys) (Temporary Traffic Prohibitions and Restrictions) Order 2015.

2. —1) In this Order:

“exempted vehicle” (*“cerbyd esempt”*) means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

“the lengths of the trunk road” (*“y darnau o’r gefnffordd”*) means the lengths of the trunk road in the County of Powys specified in the Schedule to this Order;

“works period,” (*“cyfnod y gwaith”*) means intermittent periods commencing at 09.00 hours on 12 January 2015 and ending when the temporary traffic signs for each period of works are removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

Prohibitions and Restrictions

3. Subject to the provisions of article 8, no person shall, during the works period, drive or cause or permit any vehicle with a width of or exceeding 2.5 metres to proceed in the lengths of the trunk road specified in the Schedule.

4. Subject to the provisions of article 8, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the lengths of the trunk road specified in the Schedule.

5. Subject to the provisions of article 8, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 30 miles per hour in the lengths of the trunk road specified in the Schedule.

6. Subject to the provisions of article 8, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour in the lengths of the trunk road specified in the Schedule.

7. Subject to the provisions of article 8, no person shall, during the works period, use or permit the use of a vehicle, other than an exempted vehicle, in such a way that it overtakes any other vehicle in the lengths of the trunk road specified in the Schedule, during such times as the restriction referred to in article 6 is in operation.

Application

8. The provisions of articles 3, 4, 5, 6 and 7 shall apply only during such times and to such extent as the application of the prohibitions and restrictions referred to therein are indicated by traffic signs.

Duration of this Order

9. The maximum duration for this Order shall be 6 months.

SCHEDULE

i) That length of the trunk road that extends from the centre-point of its junction with the B4385, west of Neuadd Bridge, westwards to the centre-point of its junction with the C2041 near Four Crosses.

ii) That length of the trunk road that extends from a point 516 metres east of its junction with the U2093 westwards to the centre-point of its junction with the C2111 at the Cann Office Hotel, near Llangadfan.
