**ROAD TRAFFIC, WALES**

The A5 Trunk Road  
(Conwy/Gwynedd Border to Capel  
Curig, Conwy County Borough)  
(Temporary Speed Restrictions and  
No Overtaking) Order 2015

*Made* 5 January 2015

*Coming into force* 12 January 2015

The Welsh Ministers, being the traffic authority for the relevant length of the London – Holyhead Trunk Road (A5) (“the trunk road”), are satisfied that traffic in a specified length of the trunk road should be restricted or prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

**Title, Interpretation and Commencement**

1. This Order comes into force on 12 January 2015 and its title is The A5 Trunk Road (Conwy/Gwynedd Border to Capel Curig, Conwy County Borough) (Temporary Speed Restrictions and No Overtaking) Order 2015.

2.—(1) In this Order:

“the length of the trunk road” (“*y darn o’r gefnffordd*”) means the length of the trunk road in the County Borough of Conwy that extends from the Conwy/Gwynedd border at a point 300 metres east of the centre-point of its junction with the unclassified road leading to Idwal Youth Hostel to a point 1,050 metres south-east of its junction with the A4086 at Capel Curig;

“works period” (“*cyfnod y gwaith*”) means that period commencing at 08:00 hours on 12 January 2015 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

### **Restrictions and Prohibition**

3. Subject to the provisions of article 6, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the length of the trunk road.

4. Subject to the provisions of article 6, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour in the length of the trunk road.

5. Subject to the provisions of article 6, no person shall, during the works period, use or permit the use of a vehicle in such a way that it overtakes any other vehicle in the length of the trunk road during such times as the restriction referred to in article 4 is in operation.

### **Application**

6. The provisions of articles 3, 4 and 5 shall apply only during such times and to such extent as the application of the restrictions and prohibition referred to therein is indicated by traffic signs.

### **Duration of this Order**

7. The maximum duration for this Order shall be 18 months.
