**EXPLANATORY NOTE**

Mae'r Gorchymyn hwn yn diwygio Gorchymyn Iechyd Planhigion (Tystysgrifau Allforio) (Cymru) 2006 (O.S. 2006/1701 (Cy. 163)) ("Gorchymyn 2006").

This Order amends the Plant Health (Export Certification) (Wales) Order 2006 (S.I. 2006/1701 (W. 163)) ("the 2006 Order").

Mae'r Gorchymyn hwn yn darparu ar gyfer cynnydd o 10.7% yn y ffioedd a bennir yng Ngorchymyn 2006 ar gyfer gwasanaethau o ran ceisiadau am dystysgrifau (erthygl 2(2)) a gwasanaethau cyn-allforio (erthygl 2(3)).

This Order provides for a 10.7% increase to the fees specified in the 2006 Order for services in respect of applications for certificates (article 2(2)) and pre-export services (article 2(3)).

Mae'r lefelau ffioedd y darperir ar eu cyfer yn y Gorchymyn yn ffurfio'r drydedd ran a'r rhan olaf o symudiad tuag at adennill cost lawn ffioedd.

The fee levels provided for in this Order form the third and final part of a move towards full cost recovery of fees.

The Welsh Ministers, with the consent of the Treasury, and in exercise of the powers conferred by sections 3(1) and 4A of the Plant Health Act 1967(1), make the following Order:

**Title, commencement and application**

1.—(1) The title of this Order is the Plant Health (Export Certification) (Wales) (Amendment) Order 2016.

(2) This Order comes into force on 7 December 2016 and applies in relation to Wales.

**Amendment of the Plant Health (Export  
Certification) (Wales) Order 2006**

2.—(1) The Plant Health (Export Certification) (Wales) Order 2006(2) is amended as follows.

Diwygiwyd adran 1(2) gan baragraff 43 o Atodlen 2 i Orchymyn Corff Adnoddau Naturiol Cymru (Swyddogaethau) 2013/755 (Cy. 90).
