Mae'r Rheoliadau hyn yn gweithredu Cyfarwyddeb (EU) 2015/2203 Senedd Ewrop a'r Cyngor ar gyd-ddynesu cyfreithiau'r Aelod-wladwriaethau sy'n ymwneud â chaseinau a chaseinadau wedi eu bwriadu i'w bwyta gan bobl ac yn diddymu Cyfarwyddeb y Cyngor 83/417/EEC (OJ Rhif L 314, 1.12.2015, t 1).

Mae'r Rheoliadau hyn yn dirymu ac yn disodli Rheoliadau Caseinau a Chaseinadau 1985 (O.S. 1985/2026) a Rheoliadau Caseinau a Chaseinadau (Diwygio) 1989 (O.S. 1989/2321) o ran Cymru.

Nid yw'r Rheoliadau hyn ond yn gymwys i gynhyrchion casein wedi eu bwriadu i'w bwyta gan bobl (rheoliad 3).

Mae'r Rheoliadau hyn—

- (a) yn rhagnodi diffiniadau a safonau ar gyfer cynhyrchion casein penodol (rheoliad 2 ac Atodlenni 1 i 3);
- (b) yn gwahardd defnyddio unrhyw gasein neu gaseinad wrth baratoi bwyd os nad yw'n cydymffurfio â safonau neilltuol (rheoliad 4 ac Atodlen 4);
- (c) yn ddarostyngedig i eithriadau penodedig, yn gwahardd labelu neu hysbysebu bwyd ag enwau cynhyrchion casein os nad yw'r bwyd yn gynnyrch casein neu'n cynnwys cynnyrch casein (rheoliad 5);
- (d) yn gosod gofynion ychwanegol o ran labelu cynhyrchion casein (rheoliad 6);
- (e) yn gosod rhwymedigaeth ar bob cyngor sir neu gyngor bwrdeistref sirol i orfodi'r Rheoliadau yn ei ardal (rheoliad 7);

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations implement Directive (EU) 2015/2203 of the European Parliament and of the Council on the approximation of the laws of the Member States relating to caseins and caseinates intended for human consumption and repealing Council Directive 83/417/EEC (OJ No L 314, 1.12.2015, p 1).

These Regulations revoke and replace the Caseins and Caseinates Regulations 1985 (S.I. 1985/2026) and the Caseins and Caseinates (Amendment) Regulations 1989 (S.I. 1989/2321) in relation to Wales.

These Regulations only apply to casein products intended for human consumption (regulation 3).

These Regulations—

- (a) prescribe definitions and standards for certain casein products (regulation 2 and Schedules 1 to 3);
- (b) prohibit the use of any casein or caseinate in the preparation of food if it does not comply with particular standards (regulation 4 and Schedule 4);
- (c) subject to specified exceptions, prohibit the labelling or advertisement of food with the names of casein products unless the food is or contains a casein product (regulation 5);
- (d) impose additional requirements as to the labelling of casein products (regulation 6);
- (e) impose an obligation on each county council or county borough council to enforce the Regulations in its area (regulation 7);

(f) yn cymhwyso gydag addasiadau ddarpariaethau penodol o Ddeddf Diogelwch.

Bwyd 1990 (1990 p. 16). Mae hyn yn cynnwys cymhwyso (gydag addasiadau) adran 10(1), sy'n galluogi i hysbysiad gwella gael ei gyflwyno sy'n gwneud cydymffurfedd â rheoliadau 4, 5 neu 6 o'r Rheoliadau hyn yn ofynnol. Mae'r darpariaethau, fel y maent yn cael eu cymhwyso, yn gwneud methu â chydymffurfio â hysbysiad gwella yn drosedd (rheoliad 8).

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

(f) apply certain provisions of the Food Safety Act 1990 (1990 c. 16), with modifications.

This includes the application (with modifications) of section 10(1), enabling an improvement notice to be served to require compliance with regulations 4, 5 or 6 of these Regulations. The provisions, as applied, make the failure to comply with an improvement notice an offence (regulation 8).

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

Mae Gweinidogion Cymru yn gwneud y Rheoliadau a ganlyn drwy arfer y pwerau a roddir gan adrannau 6(4), 16(1)(a), (e), (f), 17(1), 26(1), (2)(e) a (3), 31(1) a 48 o Ddeddf Diogelwch Bwyd 1990(1).

The Welsh Ministers make the following Regulations in exercise of the powers conferred by sections 6(4), 16(1)(a), (e), (f), 17(1), 26(1), (2)(e) and (3), 31(1) and 48 of the Food Safety Act 1990(1).

Yn unol ag adran 48(4A)(2) o'r Ddeddf honno, mae Gweinidogion Cymru wedi rhoi sylw i gyngor perthnasol a roddwyd iddynt gan yr Asiantaeth Safonau Bwyd cyn gwneud y Rheoliadau hyn.

In accordance with section 48(4A)(2) of that Act, the Welsh Ministers have had regard to relevant advice given by the Food Standards Agency before making these Regulations.

Ymgynghorwyd yn agored ac yn dryloyw â'r cyhoedd wrth lunio a gwerthuso'r Rheoliadau hyn yn unol â gofynion Erthygl 9 o Reoliad (EC) Rhif 178/2002 Senedd Ewrop a'r Cyngor, sy'n gosod egwyddorion cyffredinol a gofynion cyfraith bwyd, yn sefydlu Awdurdod Diogelwch Bwyd Ewrop ac yn gosod gweithdrefnau o ran materion diogelwch bwyd(1).

There has been open and transparent public consultation during the preparation and evaluation of these Regulations as required by Article 9 of Regulation (EC) No 178/2002 of the European Parliament and of the Council laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety(1).

2. Yn y Rheoliadau hyn—

ystyr “casein asid bwytdwy” (“*edible acid casein*”) yw cynnyrch llaeth a geir drwy wahanu, golchi a sychu tolch a gafwyd drwy ddefnyddio asid i waddodi llaeth sgim a/neu gynhyrchion eraill a geir o laeth ac sy'n cydymffurfio â'r safonau a nodir yn Atodlen 1;

ystyr “caseinad bwytdwy” (“*edible caseinate*”) yw cynnyrch llaeth a geir drwy effaith casein bwytdwy neu dolch colfran casein bwytdwy gyda chyfryngau niwtraleiddio, ac sydd wedyn yn cael ei sychu ac sy'n cydymffurfio â'r safonau a nodir yn Atodlen 2;

ystyr “casein cywair llaeth bwytdwy” (“*edible rennet casein*”) yw cynnyrch llaeth a geir drwy wahanu, golchi a sychu tolch llaeth sgim a/neu gynhyrchion eraill a geir o laeth; ceir y dolch drwy adwaith cywair llaeth neu ensymau tolchi eraill ac sy'n cydymffurfio â'r safonau a nodir yn Atodlen 3;

ystyr “cynnyrch casein” (“*casein product*”) yw casein asid bwytdwy, caseinad bwytdwy neu gasein cywair llaeth bwytdwy;

ystyr “y Ddeddf” (“*the Act*”) yw Deddf Diogelwch Bwyd 1990;

Title, application and commencement

1.—(1) The title of these Regulations is the Caseins and Caseinates (Wales) Regulations 2016.

(2) These Regulations apply in relation to Wales.

(3) These Regulations come into force on 22 December 2016.

Interpretation

2. In these Regulations—

“the Act” (“*y Ddeddf*”) means the Food Safety Act 1990;

“casein product” (“*cynnyrch casein*”) means edible acid casein, edible caseinate or edible rennet casein;

“edible acid casein” (“*casein asid bwytdwy*”) means a milk product obtained by separating, washing and drying the acid-precipitated coagulum of skimmed milk and/or of other products obtained from milk and complying with the standards set out in Schedule 1;

“edible caseinate” (“*caseinad bwytdwy*”) means a milk product obtained by action of edible casein or edible casein curd coagulum with neutralizing agents, followed by drying and complying with the standards set out in Schedule 2;

“edible rennet casein” (“*casein cywair llaeth bwytdwy*”) means a milk product obtained by separating, washing and drying the coagulum of skimmed milk and/or of other products obtained from milk; the coagulum is obtained through the reaction of rennet or other coagulating enzymes and complying with the standards set out in Schedule 3;

“FIC” (“*FIC*”) means Regulation (EU) No 1169/2011 of the European Parliament and of the Council on the provision of food information to consumers, amending Regulations (EC) No 1924/2006 and (EC) No 1925/2006 of the European Parliament and of the Council, and repealing Commission Directive 87/250/EEC, Council Directive 90/496/EEC, Commission Directive 1999/10/EC, Directive 2000/13/EC of the European Parliament and of the Council, Commission Directives 2002/67/EC and 2008/5/EC and Commission Regulation (EC) No 608/2004(1);

mae “gwerthu” (“*sell*”, “*sale*”) yn cynnwys meddu ar rywbeth i'w werthu a chynnig, dangos neu hysbysebu rhywbeth i'w werthu;

ystyr “Rheoliad (EC) Rhif 1332/2008” (“*Regulation (EC) No 1332/2008*”) yw Rheoliad (EC) Rhif 1332/2008 Senedd Ewrop a'r Cyngor yn ymwneud ag ensymau bwyd ac sy'n diwygio Cyfarwyddeb y Cyngor 83/417/EEC, Rheoliad y Cyngor (EC) Rhif 1493/1999, Cyfarwyddeb 2000/13/EC, Cyfarwyddeb y Cyngor 2001/112/EC a Rheoliad (EC) Rhif 258/97(2).

“food business operator” (“*gweithredydd busnes bwyd*”) has the meaning given in Article 3 of Regulation (EC) No 178/2002 of the European Parliament and of the Council;

“Regulation (EC) No 1332/2008 (“*Rheoliad (EC) Rhif 1332/2008*”) means Regulation (EC) No 1332/2008 of the European Parliament and of the Council on food enzymes and amending Council Directive 83/417/EEC, Council Regulation (EC) No 1493/1999, Directive 2000/13/EC, Council Directive 2001/112/EC and Regulation (EC) No 258/97(2);

“sell” (“*gwerthu*”) includes possess for sale and offer, expose or advertise for sale, and “sale” (“*gwerthu*”) is to be construed accordingly.

Cwmpas

3. Mae'r Rheoliadau hyn yn gymwys i gaseinau a chaseinadau wedi eu bwriadu i'w gwerthu ar gyfer eu bwyta gan bobl.

Cyfyngu ar ddefnyddio caseinau a chaseinadau wrth baratoi bwyd

4.—(1) Ni chaiff unrhyw berson ddefnyddio unrhyw gasein neu gaseinad wrth baratoi bwyd os nad yw'n cydymffurfio â'r safonau a nodir yn Atodlen 4.

(2) Rhaid i berson sy'n marchnata caseinau neu gaseinadau nad ydynt yn cydymffurfio â pharagraff (1), at ddiben ac eithrio defnyddio'r caseinau neu gaseinadau wrth baratoi bwyd, ddangos yn benodol, neu awgrymu'n glir natur neu ansawdd y cynnyrch neu'r defnydd y bwriedir ei wneud ohono.

Cyfyngu cyffredinol ar farchnata cynhyrchion casein

5.—(1) Ni chaiff unrhyw berson werthu unrhyw fwyd â label sy'n cynnwys enw unrhyw gynnyrch casein, pa un a yw wedi ei gysylltu â'r pecyn neu'r cynhwysydd neu wedi ei argraffu arno ai peidio, oni chydymffurfir â'r gofynion a nodir ym mharagraff (4).

(2) Ni chaiff unrhyw berson arddangos unrhyw docyn neu hysbysiad gydag unrhyw fwyd sy'n cael ei gynnig neu ei ddangos i'w werthu gan y person hwnnw, sy'n cynnwys enw unrhyw gynnyrch casein oni chydymffurfir â'r gofynion a nodir ym mharagraff (4).

Scope

3. These Regulations apply to caseins and caseinates intended for sale for human consumption.

Restriction on the use of caseins and caseinates in the preparation of food

4.—(1) No person may use any casein or caseinate in the preparation of food if it does not comply with the standards set out in Schedule 4.

(2) A person marketing caseins or caseinates which do not comply with paragraph (1), for a purpose other than the caseins or caseinates being used in the preparation of food, must indicate explicitly or by clear implication the nature, quality or intended use of the product.

General restriction on marketing of casein products

5.—(1) No person may sell any food with a label, whether or not attached to or printed on the package or container, which includes the name of any casein product unless the requirements set out in paragraph (4) are complied with.

(2) No person may display with any food offered or exposed for sale by that person any ticket or notice which includes the name of any casein product unless the requirements set out in paragraph (4) are complied with.

(4) Y gofynion yw—

- (a) bod y bwyd yn gynnyrch casein neu yn cynnwys cynnyrch casein; neu
- (b) bod yr enw yn cael ei ddefnyddio mewn cyddestun sy'n dangos yn benodol neu'n awgrymu'n glir nad yw'r bwyd yn gynnyrch casein ac nad yw'n cynnwys cynnyrch casein.

Labelu cynhyrchion casein

6.—(1) Heb leihau effaith darpariaethau FIC, ni chaiff unrhyw berson werthu unrhyw gynnyrch casein oni bai ei fod wedi ei farcio neu ei labelu â'r manylion a ganlyn—

- (a) enw'r cynnyrch casein hwnnw fel y'i diffinnir yn rheoliad 2 ac, yn achos caseinadau bwydadwy, gan ddangos y cation neu gationau a restrir ym mharagraff 4 o Atodlen 2;
- (b) yn achos cynhyrchion casein sy'n cael eu gwerthu fel cymysgeddau—
 - (i) y geiriau “mixture of” wedi eu dilyn gan enwau'r cynhyrchion casein sydd yn y cymysgedd, yn nhrefn ddisgynnol eu pwysau;
 - (ii) yn achos caseinadau bwydadwy, gan ddangos y cation neu gationau a restrir ym mharagraff 4 o Atodlen 2;
 - (iii) yn achos cymysgeddau sy'n cynnwys caseinadau bwydadwy, y cynnwys protein;
- (c) pwysau net y cynnyrch casein, wedi ei fynegi mewn cilogramau neu gramau;
- (d) enw neu enw busnes a chyfeiriad y gweithredydd busnes bwyd y marchnetir y cynnyrch o dan ei enw neu ei enw busnes, neu, os nad yw'r gweithredydd busnes bwyd hwnnw wedi ei sefydlu yn yr Undeb Ewropeaidd, enw neu enw busnes a chyfeiriad y sawl a'i mewnfiorodd i farchnad yr Undeb Ewropeaidd;
- (e) yn achos cynnyrch casein wedi ei fewnforio o wledydd y tu allan i'r Undeb Ewropeaidd, enw gwlad tarddiad y cynnyrch; ac
- (f) lot adnabod y cynnyrch casein neu'r dyddiad cynhyrchu.

(2) Rhaid i'r manylion y mae paragraff (1) yn eu gwneud yn ofynnol fod yn hawdd i'w gweld, yn glir i'w darllen, yn annileadwy ac wedi eu rhoi yn Saesneg, naill ai yn unig neu yn ogystal ag unrhyw iaith arall.

(3) No person may publish, or be a party to the publication of, any advertisement for food which includes the name of a casein product unless the requirements set out in paragraph (4) are complied with.

(4) The requirements are that—

- (a) the food is or contains a casein product; or
- (b) the name is used in such a context as to indicate explicitly or by clear implication that the food is not a casein product and does not contain one.

Labelling of casein products

6.—(1) Without prejudice to the provisions of FIC, no person may sell any casein product unless it is marked or labelled with—

- (a) the name of that casein product as defined in regulation 2 and in the case of edible caseinates with an indication of the cation or cations listed in paragraph 4 of Schedule 2;
- (b) in the case of casein products sold as mixtures—
 - (i) the words “mixture of” followed by the names of the casein products which make up the mixture, in descending order of weight;
 - (ii) an indication of the cation or cations listed in paragraph 4 of Schedule 2 in the case of edible caseinates;
 - (iii) in the case of mixtures containing edible caseinates, the protein content;
- (c) the net quantity of the casein product, expressed in kilograms or grams;
- (d) the name or business name and the address of the food business operator under whose name or business name the product is marketed or, if that food business operator is not established in the European Union, the importer into the European Union market;
- (e) in the case of a casein product imported from countries outside the European Union, the name of the country of origin; and
- (f) the lot identification of the casein product or the date of production.

(2) The particulars required by paragraph (1) must be easily visible, clearly legible, indelible and given in English, either exclusively or in addition to any other language.

(3) Caniateir rhoi'r manylion y cyfeirir atynt ym mharagraff (1)(b)(iii), (c), (d) ac (e) mewn dogfen sy'n cyd-fynd â'r cynnyrch.

(4) Heb leihau effaith darpariaethau FIC, pan fo cynnwys protein llaeth unrhyw gynnyrch casein dros y lleiafswm a nodir ar gyfer y cynnyrch hwnnw—

- (a) yng nghofnod 2 o'r tabl ym mharagraff 1 o Atodlen 1 mewn perthynas â chaseinau asid bwytdwy;
- (b) yng nghofnod 2 o'r tabl ym mharagraff 1 o Atodlen 2 mewn perthynas â chaseinau bwytdwy; neu
- (c) yng nghofnod 2 o'r tabl ym mharagraff 1 o Atodlen 3 mewn perthynas â chasein cywair llaeth bwytdwy,

caiff person farcio'r ffaith ar becyn, label neu gynhwysydd y cynnyrch hwnnw.

(8) Where a casein product that is marked or labelled with "mixture of" in accordance with (1)(b)(i) is marked or labelled in Welsh in addition to English, the words "cymysgedd o" must be used followed by the names of the casein products which make up the mixture, in descending order of weight.

Enforcement

7. It is the duty of a food authority within its area and a port health authority within its district to enforce these Regulations.

Application and modification of provisions of the Act

8.—(1) Section 10(1) and (2) of the Act (improvement notices) applies for the purposes of these Regulations with the modification (in the case of section 10(1)) set out in Part 1 of Schedule 5 for the purposes of—
