The A4042 Trunk Road (Grove Park Roundabout, Newport to Cwmbran Roundabout, Torfaen) (Temporary Prohibition of Vehicles) Order 2016

Made 18 July 2016

Coming into force 23 July 2016

The Welsh Ministers, being the traffic authority for the relevant length of the Newport – Shrewsbury Trunk Road (A4042) ("the trunk road"), are satisfied that traffic in specified lengths of the trunk road should be prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

Title, Interpretation and Commencement

1. This Order comes into force on 23 July 2016 and its title is The A4042 Trunk Road (Grove Park Roundabout, Newport to Cwmbran Roundabout, Torfaen) (Temporary Prohibition of Vehicles) Order 2016.

2.—(1) In this Order:

"exempted vehicle" ("cerbyd esempt") means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

"the length(s) of the trunk road" ("y darn(au) o'r gefnffordd") means those lengths of the trunk road in the City of Newport and County Borough of Torfaen specified in the Schedule to this Order;

"works period" ("cyfnod y gwaith") means intermittent periods commencing at 20:00 hours on 23 July 2016 and ending when the temporary traffic signs for each period of works are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

Prohibition

3. No person shall, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed in the lengths of the trunk road specified in the Schedule.

Application

4. The prohibition in article 3 applies only during such times and to such extent as indicated by traffic signs.

Duration of this Order

5. The maximum duration of this Order shall be 18 months.

The length of the trunk road between its junction with the northern side of Turnpike Roundabout and its junction with the southern side of Edlogan Way Roundabout, Torfaen.

The length of the trunk road between its junction with the northern side of Edlogan Way Roundabout and its junction with the southern side of Cwmbran Roundabout, Torfaen.
