Mae'r Rheoliadau hyn yn diwygio Rheoliadau'r Gwasanaeth Iechyd Gwladol (Gwasanaethau Offthalmig Cyffredinol) 1986 (1986/975) ("Rheoliadau 1986"), Rheoliadau'r Gwasanaeth Iechyd Gwladol (Ffioedd a Thaliadau Optegol) 1997 (1997/818) ("Rheoliadau 1997") a Rheoliadau'r Gwasanaeth Iechyd Gwladol (Treuliau Teithio a Pheidio â Chodi Tâl) (Cymru) 2007 (2007/1104 (Cy. 116)) ("Rheoliadau 2007").

Mae rheoliad 3 yn diwygio Rheoliadau 1986 i estyn y cyfnod o amser y bydd derbynyddion credyd cynhwysol yn gymwys i gael profion golwg yn rhad ac am ddim hyd at fis Mawrth 2017.

Mae rheoliad 4 yn diwygio Rheoliadau 1997 i estyn y cyfnod o amser y bydd derbynyddion credyd cynhwysol yn gymwys i gael taliadau i dalu'r costau am declynnau optegol, neu i gael taliadau i gyfrannu tuag at y costau hynny, hyd at fis Mawrth 2017.

Mae rheoliad 5 yn diwygio Rheoliadau 2007 i estyn y cyfnod o amser y bydd derbynyddion credyd cynhwysol yn gymwys i gael eu treuliau teithio GIG wedi eu talu'n llawn ac i beidio â thalu ffi GIG hyd at fis Mawrth 2017.

Mae'r Rheoliadau hyn yn dirymu Rheoliadau'r Gwasanaeth Iechyd Gwladol (Diwygiadau Canlyniadol Diwygio Lles) (Cymru) 2015 (2015/631 (Cy. 51)).

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the National Health Service (General Ophthalmic Services) Regulations 1986 (1986/975) ("the 1986 Regulations"), the National Health Service (Optical Charges and Payments) Regulations 1997 (1997/818) ("the 1997 Regulations") and the National Health Service (Travelling Expenses and Remission of Charges) (Wales) Regulations 2007 (2007/1104 (W. 116)) ("the 2007 Regulations").

Regulation 3 amends the 1986 Regulations to extend the time period recipients of universal credit are eligible to receive free sight tests to March 2017.

Regulation 4 amends the 1997 Regulations to extend the time period recipients of universal credit are eligible to receive a payment to meet, or to contribute towards the costs of optical appliances to March 2017.

Regulation 5 amends the 2007 Regulations to extend the time period recipients of universal credit are entitled to payment in full of NHS travelling expenses and the full remission of an NHS charge to March 2017.

These Regulations revoke the National Health Service (Welfare Reform Consequential Amendments) (Wales) Regulations 2015 (2015/631 (W. 51)).

The Welsh Ministers in exercise of the powers conferred on them by sections 71, 128, 129, 130, 131 and 203(9) and (10) of the National Health Service (Wales) Act 2006(1) make the following Regulations.

Title, commencement and application

1.—(1) The title of these Regulations is the National Health Service (Welfare Reform Consequential Amendments) (Wales) Regulations 2016 and they come into force on 1 April 2016.

(2) These Regulations apply in relation to Wales.

Interpretation

2. In these Regulations—

"the 1986 Regulations" ("*Rheoliadau 1986*") means the National Health Service (General Ophthalmic Services) Regulations 1986(2);

"the 1997 Regulations" ("*Rheoliadau 1997*") means the National Health Service (Optical Charges and Payments) Regulations 1997(3); and
