EXPLANATORY NOTE

(This note is not part of the Regulations)

Mae'r Rheoliadau hyn wedi eu gwneud o dan adran 198 o Ddeddf Gwasanaethau Cymdeithasol a Llesiant (Cymru) 2014 ("Deddf 2014"). Maent yn gwneud diwygiadau canlyniadol i ddeddfwriaeth sylfaenol sy'n ychwanegol at ddiwygiadau a wnaed yn Rheoliadau Deddf Gwasanaethau Cymdeithasol a Llesiant (Cymru) 2014 (Diwygiadau Canlyniadol) 2016.

Mae rheoliad 2 o'r Rheoliadau hyn yn diwygio Deddf Plant 1989 drwy ddatgymhwyso adran 25C(2) o ran Cymru.

Mae rheoliad 3 yn diwygio adran 2(6)(c) o Ddeddf Llywodraeth Leol a Thai 1989 drwy roi "section 144 of the Social Services and Well-being (Wales) Act 2014" yn lle'r cyfeiriad at "section 6 of the Local Authority Social Services Act 1970".

Cyflwynodd Deddf Plant a Theuluoedd 2014 "child arrangements order", yn lle'r gorchymyn preswyllo a'r gorchymyn cyswllt. Mae rheoliad 4 yn diwygio Deddf 2014 drwy roi "gorchymyn trefniadau plentyn" yn lle'r cyfeiriadau at "gorchymyn preswyllo" yn adrannau 76 ac 81 i adlewyrchu'r newid hwn.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Aseidiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal aseiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

These Regulations are made under section 198 of the Social Services and Well-being (Wales) Act 2014 ("the 2014 Act"). They make consequential amendments to primary legislation which are in addition to amendments made in the Social Services and Well-being (Wales) Act 2014 (Consequential Amendments) Regulations 2016.

Regulation 2 of these Regulations amends the Children Act 1989 by disapplying section 25C(2) in relation to Wales.

Regulation 3 amends section 2(6)(c) of the Local Government and Housing Act 1989 by replacing the reference to "section 6 of the Local Authority Social Services Act 1970" with "section 144 of the Social Services and Well-being (Wales) Act 2014".

The Children and Families Act 2014 introduced a "child arrangements order", replacing residence and contact orders. Regulation 4 amends the 2014 Act by replacing references in sections 76 and 81 to "residence order" with "child arrangements order" to reflect this change.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

The Social Services and Well-being
(Wales) Act 2014 (Consequential
Amendments) Regulations 2017

Made 25 October 2017
Coming into force 1 December 2017

The Welsh Ministers make the following Regulations in exercise of the powers conferred by section 198 of the Social Services and Well-being (Wales) Act 2014(1).

A draft of these Regulations was laid before the National Assembly for Wales under section 196(6) of that Act and has been approved by a resolution of the National Assembly for Wales.

Title and commencement

1.—(1) The title of these Regulations is the Social Services and Well-being (Wales) Act 2014 (Consequential Amendments) Regulations 2017.

(2) These Regulations come into force on 1 December 2017.

Children Act 1989

2.—(1) The Children Act 1989(2) is amended as follows.

(2) Omit section 25C(2)(3) (referred cases, regulations in respect of Wales).

Deddf Llywodraeth Leol a Thai 1989

3.—(1) Mae Deddf Llywodraeth Leol a Thai 1989(1) wedi ei diwygio fel a ganlyn.

(2) Yn adran 2(6)(c) yn lle “section 6 of the Local Authority Social Services Act 1970” rhodder “section 144 of the Social Services and Well-being (Wales) Act 2014”.

Deddf Gwasanaethau Cymdeithasol a Llesiant (Cymru) 2014

4.—(1) Mae Deddf Gwasanaethau Cymdeithasol a Llesiant (Cymru) 2014 wedi ei diwygio fel a ganlyn.

(2) Yn adrannau 76 ac 81, yn lle “gorchymyn preswyllo”, ble bynnag y mae'r geiriau yn digwydd, rhodder “gorchymyn trefniadau plentyn”.

Local Government and Housing Act 1989

3.—(1) The Local Government and Housing Act 1989(1) is amended as follows.

(2) In section 2(6)(c) for “section 6 of the Local Authority Social Services Act 1970” substitute “section 144 of the Social Services and Well-being (Wales) Act 2014”.

Social Services and Well-being (Wales) Act 2014

4.—(1) The Social Services and Well-being (Wales) Act 2014 is amended as follows.

(2) In sections 76 and 81, for “residence order” wherever the words occur, substitute “child arrangements order”.
