**ROAD TRAFFIC, WALES**

**The A494 Trunk Road (Tŷ Nant,  
near Cefnddwysarn, Gwynedd)  
(Temporary Traffic Prohibitions &  
Restrictions) Order 2017**

*Made* 29 December 2017

*Coming into force* 8 January 2018

The Welsh Ministers, being the traffic authority for the relevant length of the Dolgellau to South of Birkenhead Trunk Road (A494), are satisfied that traffic on a specified length of the trunk road should be prohibited and/or restricted because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984(1), make this Order.

**Title, Interpretation and Commencement**

**1.** This Order comes into force on 8 January 2018 and its title is The A494 Trunk Road (Tŷ Nant, near Cefnddwysarn, Gwynedd) (Temporary Traffic Prohibitions & Restrictions) Order 2017.

**2.—(1)** In this Order:

“exempted vehicle” (“*cerbyd esempt*”) means:

- (a) any vehicle being used by the emergency services; and
- (b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders

of a member of the armed forces of the Crown, who is a member of the special forces—

- (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or
- (ii) for the purpose of training a person in driving vehicles at high speeds;

“special forces” (“*lluoedd arbennig*”) means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

“the trunk road” (“*y gefnffordd*”) means the Dolgellau to South of Birkenhead Trunk Road (A494) south-west of Cefnddwysarn in the County of Gwynedd that extends from a point 10 metres west of the centre-point of its junction with the access road to Nyrs Cynlas Forestry to a point 450 metres west of that junction;

“works period” (“*cyfnod y gwaith*”) means intermittent periods commencing at 07:30 hours on 8 January 2018 and ending when the temporary traffic signs for each period of works are removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

### **Prohibitions and Restrictions**

**3.** No person shall, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed on the length of the trunk road.

**4.** No person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour on the length of the trunk road.

**5.** No person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour on the length of the trunk road.

**6.** No person shall, during the works period, use or permit the use of a vehicle, other than an exempted vehicle, in such a way that it overtakes any other vehicle on the length of the trunk road during such times as the restriction in article 5 is in force.

### **Suspension**

**7.** Any statutory provisions restricting the speed of vehicles on the length of the trunk road are suspended

during such times as the restrictions specified in articles 4 and 5 are in operation.

#### **Application**

**8.**—(1) The prohibitions and restrictions in articles 3, 4, 5 and 6 apply only during such times and to such extent as indicated by traffic signs.

(2) No speed limits imposed by this Order apply to an exempted vehicle.

#### **Duration of this Order**

**9.** The maximum duration of this Order shall be 12 months.
