EXPLANATORY NOTE

(This note is not part of the Order)

Parhawyd â bodolaeth Cyngor y Gweithlu Addysg (“y Cyngor”) gan adran 2 o Ddeddf Addysg (Cymru) 2014 (“Deddf 2014”). Mae adran 4 o Ddeddf 2014 yn nodi prif swyddogaethau'r Cyngor. Mae adran 5 o Ddeddf 2014 yn caniatáu i Weinidogion Cymru wneud Gorchymyn sy'n rhoi swyddogaethau ychwanegol i'r Cyngor neu'n gosod swyddogaethau ychwanegol arno. Yn unol â hynny, mae'r Gorchymyn hwn yn rhoi swyddogaethau ychwanegol i'r Cyngor sy'n ymwneud ag achredu cyrsiau neu raglenni astudio hyfforddiant cychwynnol athrawon ysgol ac â thynnu achrediad yn ôl (erthygl 3).

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Gorchymyn hwn. O ganlyniad, lluniwyd asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Gorchymyn hwn. Gellir cael copi oddi wrth yr Adran Addysg a Gwasanaethau Cyhoeddus yn Llywodraeth Cymru, Parc Cathays, Caerdydd, CF10 3NQ.

The Education Workforce Council (“the Council”) was continued in existence by section 2 of the Education (Wales) Act 2014 (“the 2014 Act”). Section 4 of the 2014 Act sets out the main functions of the Council. Section 5 of the 2014 Act allows the Welsh Ministers to make an Order conferring or imposing additional functions on the Council. Accordingly, this Order confers additional functions on the Council relating to the accreditation and withdrawal of accreditation of courses or programmes of study of initial school teacher training (article 3).

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to this Order. As a result, a regulatory impact assessment has been prepared as to the likely costs and benefits of complying with this Order. A copy can be obtained from the Department for Education and Public Services in the Welsh Government, Cathays Park, Cardiff, CF10 3NQ.

Mae Gweinidogion Cymru, drwy arfer y pwerau a roddir iddynt gan adrannau 5 a 47(1) o Ddeddf Addysg (Cymru) 2014(1), ar ôl ymgynghori â'r personau hynny y maent yn ystyried eu bod yn briodol, yn gwneud y Gorchymyn a ganlyn.

The Welsh Ministers, in exercise of the powers conferred on them by sections 5 and 47(1) of the Education (Wales) Act 2014(1), having consulted such persons as they consider appropriate make the following Order.

Yn unol ag adran 47(2) o Ddeddf Addysg (Cymru) 2014, gosodwyd drafft o'r Gorchymyn hwn gerbron Cynulliad Cenedlaethol Cymru ac fe'i cymeradwywyd ganddo drwy benderfyniad.

In accordance with section 47(2) of the Education (Wales) Act 2014, a draft of this Order was laid before the National Assembly for Wales and approved by a resolution of the National Assembly for Wales.

Enwi, cychwyn a chymhwyso

Title, commencement and application

1.—(1) Enw'r Gorchymyn hwn yw Gorchymyn Cyngor y Gweithlu Addysg (Achredu Hyfforddiant Cychwynnol Athrawon) (Swyddogaethau Ychwanegol) (Cymru) 2017.

1.—(1) The title of this Order is the Education Workforce Council (Accreditation of Initial Teacher Training) (Additional Functions) (Wales) Order 2017.

(2) Daw'r Gorchymyn hwn i rym ar 16 Chwefror 2017.

(2) This Order comes into force on 16 February 2017.

(3) Mae'r Gorchymyn hwn yn gymwys o ran Cymru.

(3) This Order applies in relation to Wales.

Dehongli

2. Yn y Gorchymyn hwn—

ystyr “y Cyngor” (“*the Council*”) yw Cyngor y Gweithlu Addysg y parheir â’i fodolaeth gan adran 2 o Ddeddf Addysg (Cymru) 2014;

ystyr “y meini prawf achredu” (“*the accreditation criteria*”) yw’r meini prawf ar gyfer yr achrediad neu ar gyfer tynnu achrediad yn ôl a bennir gan Weinidogion Cymru o dan reoliadau a wneir o dan adran 132 o Ddeddf Addysg 2002(1).

Swyddogaethau ychwanegol

3.—(1) Mae’r Cyngor i gael y swyddogaethau o—

- (a) achredu cyrsiau neu raglenni hyfforddiant cychwynnol athrawon ysgol (“y Gwasanaeth”);
- (b) monitro cydymffurfedd cyrsiau neu raglenni achrededig hyfforddiant cychwynnol athrawon â’r meini prawf achredu;
- (c) tynnu achrediad cyrsiau neu raglenni hyfforddiant cychwynnol athrawon yn ôl; a
- (d) codi ffioedd mewn cysylltiad â darparu’r Gwasanaeth.

(2) Ni chaiff y ffioedd a godir gan y Cyngor yn unol â pharagraff (1)(d) fod yn fwy na chost darparu’r Gwasanaeth.

Interpretation

2. In this Order—

“the accreditation criteria” (“*y meini prawf achredu*”) means the criteria for the accreditation or the withdrawal of accreditation specified by the Welsh Ministers under regulations made under section 132 of the Education Act 2002(1);

“the Council” (“*y Cyngor*”) means the Education Workforce Council continued in existence by section 2 of the Education (Wales) Act 2014.

Additional functions

3.—(1) The Council is to have the functions of—

- (a) accrediting courses or programmes of initial school teacher training (“the Service”);
- (b) monitoring compliance of accredited courses or programmes of initial teacher training with the accreditation criteria;
- (c) withdrawing accreditation of courses or programmes of initial school teacher training; and
- (d) charging fees in connection with providing the Service.

(2) The fees charged by the Council pursuant to paragraph (1)(d) may not exceed the cost of providing the Service.

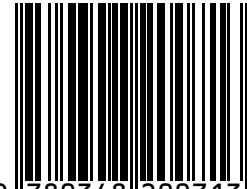
