NODYN ESBONIADOL

Mae adran 49B o Ddeddf Addysg Bellach ac Uwch 1992 yn galluogi Gweinidogion Cymru i rannu “gwybodaeth am gyrcfannau” â sefydliadau addysg bellach yng Nghymru.

Mae'r Rheoliadau hyn yn gwneud darpariaeth mewn cysylltiad â hi y mae gweithgareddau myfyriwr sydd wedi ymadael â sefydliad addysg bellach yng Nghymru yn cyfrif fel “gwybodaeth am gyrcfannau” at ddibenion adran 49B(2) ac adran 49B(3) o Ddeddf Addysg Bellach ac Uwch 1992. Mae rheoliad 3 yn nodi'r gweithgareddau a'r cyfnod amser y mae rhaid iddynt ddigwydd ynddo.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

EXPLANATORY NOTE

(This note is not part of the Regulations)

Section 49B of the Further and Higher Education Act 1992 enables the Welsh Ministers to share “destination information” with further education institutions in Wales.

These Regulations make provision in respect of which activities of a student, that has left a further education institution in Wales, count as “destination information” for the purposes of section 49B(2) and 49B(3) of the Further and Higher Education Act 1992. Regulation 3 sets out the activities and the time period in which they must occur.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

The Welsh Ministers, in exercise of the powers conferred by sections 49B(3), 49B(4) and 89(4) of the Further and Higher Education Act 1992(1), make the following Regulations:

Title, commencement and application

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Addysg (Gwybodaeth am Gyrcfannau) (Gweithgareddau Rhagnodedig) (Cymru) 2017.

1.—(1) The title of these Regulations is the Education (Destination Information) (Prescribed Activities) (Wales) Regulations 2017.

(2) Mae'r Rheoliadau hyn yn gymwys o ran Cymru ac yn dod i rym ar 6 Hydref 2017.

(2) These Regulations apply in relation to Wales and come into force on 6 October 2017.

Interpretation

2. Yn y Rheoliadau hyn—

2. In these Regulations—

ystyr “blwyddyn academiaidd” (“*academic year*”) yw unrhyw gyfnod sy'n dechrau ar 1 Awst neu ar ôl hynny ac sy'n dod i ben ar 31 Gorffennaf neu cyn hynny.

“academic year” (“*blwyddyn academiaidd*”) means any period commencing on or after 1 August and ending on or before 31 July.

Gweithgareddau Rhagnodedig

3.—(1) At ddibenion adran 49B(2) a 49B(3) o Ddeddf Addysg Bellach ac Uwch 1992, ar gyfer y flwyddyn academaidd yn union ar ôl y flwyddyn academaidd pryd y peidiodd y myfyriwr â bod yn fyfyrwr yn y sefydliad perthnasol, mae'r gweithgareddau rhagnodedig fel a ganlyn—

- (a) unrhyw ffurf o addysg a wneir gan y myfyriwr;
- (b) unrhyw ffurf o gyflogaeth a wneir gan y myfyriwr; ac
- (c) unrhyw ffurf o hyfforddiant a wneir gan y myfyriwr.

Prescribed Activities

3.—(1) For the purposes of section 49B(2) and 49B(3) of the Further and Higher Education Act 1992, for the academic year immediately following the academic year in which the student ceased to be a student of the relevant institution, the prescribed activities are—

- (a) any form of education undertaken by the student;
- (b) any form of employment undertaken by the student; and
- (c) any form of training undertaken by the student.

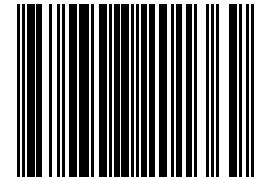
