EXPLANATORY NOTE

(This note is not part of the Order)

This Order made by the Welsh Ministers amends the Public Health (Wales) Act 2017 (Commencement) Order 2017 ("the original Commencement Order").

Article 3 of the original Commencement Order brings into force on 1 January 2018 provisions of the Public Health (Wales) Act 2017 relating to the intimate piercing of children (Part 5 and section 94 for the purposes of Part 5).

This Order revokes article 3 of the original Commencement Order, which was included in error. Those provisions will be brought into force at a later date by a separate commencement order.
