Mae'r Rheoliadau hyn yn diwygio Rheoliadau Gofal Cymdeithasol Cymru (Pennu Gweithwyr Gofal Cymdeithasol) (Cofrestru) 2016.

These Regulations amend the Social Care Wales (Specification of Social Care Workers) (Registration) Regulations 2016.

Mae adran 80(1)(b) o Ddeddf Rheoleiddio ac Arolygu Gofal Cymdeithasol (Cymru) 2016 ("y Ddeddf") yn ei gwneud yn ofynnol i Ofal Cymdeithasol Cymru gadw cofrestr o weithwyr gofal cymdeithasol o unrhyw ddisgrifiad a bennir gan Weinidogion Cymru.

Section 80(1)(b) of the Regulation and Inspection of Social Care (Wales) Act 2016 ("the Act") requires Social Care Wales to keep a register of social care workers of such description as may be specified by the Welsh Ministers.

Mae'r Rheoliadau hyn yn pennu disgrifiad ychwanegol o weithwyr gofal cymdeithasol y mae rhaid i Ofal Cymdeithasol Cymru gadw cofrestr mewn cysylltiad â hwy, sef y rheini sydd wedi eu cyflogi neu wedi eu cymryd ymlaen gan wasanaeth cymorth cartref rheoleiddiedig i ddarparu gofal a chymorth i bersonau y cyfeirir atynt ym mharagraff 8 o Atodlen 1 i'r Ddeddf.

These Regulations specify an additional description of social care workers in respect of which Social Care Wales must keep a register, namely those who are employed or engaged by a regulated domiciliary support service to provide care and support to persons referred to in paragraph 8 of Schedule 1 to the Act.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Aseidiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, lluniwyd aseiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn. *Made* 15 February 2018

*Coming into force* 2 April 2018

The Welsh Ministers, in exercise of the powers conferred upon them by sections 80(1)(b) and 187(1)(b) of the Regulation and Inspection of Social Care (Wales) Act 2016(1), make the following Regulations.

In accordance with section 187(2)(n) of that Act, a draft of this instrument has been laid before, and approved by a resolution of, the National Assembly for Wales.

**Title and commencement**

1.—(1) The title of these Regulations is the Social Care Wales (Specification of Social Care Workers) (Registration) (Amendment) Regulations 2018.

(2) These Regulations come into force on 2 April 2018.

**Interpretation**

2. In these Regulations "the 2016 Regulations" ("*Rheoliadau 2016*") means the Social Care Wales (Specification of Social Care Workers) (Registration) Regulations 2016(2).

## Diwygio rheoliad 2 o Reoliadau 2016

3. Yn rheoliad 2 (dehongli) o Reoliadau 2016, mewnosoder y canlynol yn y lle priodol—

“mae i “*gwasanaeth cymorth cartref*” (“*domiciliary support service*”) yr un ystyr ag a roddir yn adran 2(1)(h) o’r Ddeddf a pharagraff 8 o Atodlen 1 iddi, yn ddarostyngedig i reoliad 3(1) o Reoliadau 2017;”;

“ystyr “*Rheoliadau 2017*” (“*the 2017 Regulations*”) yw Rheoliadau Gwasanaethau Rheoleiddiedig (Darparwyr Gwasanaethau ac Unigolion Cyfrifol) (Cymru) 2017(1).”

## Diwygio rheoliad 3 o Reoliadau 2016

4. Mae rheoliad 3 (pennu gweithwyr gofal cymdeithasol) o Reoliadau 2016 wedi ei ddiwygio fel a ganlyn—

(a) ar ddiwedd paragraff (2)(c), yn lle “.” rhodder “;”; a

(b) ar ôl paragraff (2)(c) mewnosoder—

“(d) sydd—

(i) wedi eu cyflogi (pa un ai fel cyflogai neu fel gweithiwr), neu

(ii) wedi eu cymryd ymlaen o dan gontract am wasanaethau,

gan ddarparwr gwasanaeth cymorth cartref er mwyn darparu gofal a chymorth i berson y cyfeirir ato ym mharagraff 8(1) o Atodlen 1 i’r Ddeddf.

(3) At ddibenion y rheoliad hwn, mae i’r termau “cyflogai”, “cyflogaeth”(2) a “gweithiwr” yr un ystyron ag “employee”, “employment” a “worker” yn adran 230(1), (5) a (3) yn y drefn honno o Ddeddf Hawliau Cyflogaeth 1996(3).”

## Amendment to regulation 2 of the 2016 Regulations

3. In regulation 2 (interpretation) of the 2016 Regulations, insert the following in the appropriate place—

““the 2017 Regulations” (“*Rheoliadau 2017*”) means the Regulated Services (Service Providers and Responsible Individuals) (Wales) Regulations 2017(1);”;

““domiciliary support service” (“*gwasanaeth cymorth cartref*”) has the same meaning as that given in section 2(1)(h) of and paragraph 8 of Schedule 1 to the Act, subject to regulation 3(1) of the 2017 Regulations;”.

## Amendment to regulation 3 of the 2016 Regulations

4. Regulation 3 (specification of social care workers) of the 2016 Regulations is amended as follows—

(a) at the end of paragraph (2)(c), for “.” substitute “;”; and

(b) after paragraph (2)(c) insert—

“(d) who are—

(i) employed (whether as an employee or a worker), or

(ii) engaged under a contract for services,

by a service provider of a domiciliary support service in order to provide care and support to a person referred to in paragraph 8(1) of Schedule 1 to the Act.

(3) For the purposes of this regulation, the terms “employee” (“*cyflogai*”), “employment” (“*cyflogaeth*”(2) and “worker” (“*gweithiwr*”) have the same meanings as in section 230(1), (5) and (3) respectively of the Employment Rights Act 1996(3).”
