Mae'r Gorchymyn hwn, sy'n gymwys o ran Cymru, yn diwygio Gorchymyn Moch (Cofnodion, Adnabod a Symud) (Cymru) 2011 (O.S. 2011/2830) (Cy. 303).

This Order, which applies in relation to Wales, amends the Pigs (Records, Identification and Movement) (Wales) Order 2011 (S.I. 2011/2830) (W. 303).

Mae'n dileu'r diffiniadau o MLCSL (Meat and Livestock Commercial Services Limited) a BPEX (i bob pwrpas Gweithrediaeth Moch Prydain) o erthygl 2 ac yn mewnosod diffiniad newydd o AHDB (y Bwrdd Datblygu Amaethyddiaeth a Garddwriaeth). Caiff pob cyfeiriad dilynol at MLCSL a BPEX eu disodli gan AHDB.

It removes the definitions of MLCSL (Meat and Livestock Commercial Services Limited) and BPEX (in effect the British Pig Executive) from article 2 and inserts a new definition of AHDB (Agricultural and Horticultural Development Board). All subsequent references to MLCSL and BPEX are replaced by AHDB.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Aseidiadau Effaith Rheoleiddiol mewn perthynas â'r Gorchymyn hwn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Gorchymyn hwn gan fod y diwygiadau yn rhai technegol eu natur.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to this Order. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with this Order as the amendments are technical in nature.

1.—(1) Enw'r Gorchymyn hwn yw Gorchymyn Moch (Cofnodion, Adnabod a Symud) (Cymru) (Diwygio) 2018.

1.—(1) The title of this Order is the Pigs (Records, Identification and Movement) (Wales) (Amendment) Order 2018.

(2) Mae'r Gorchymyn hwn yn gymwys o ran Cymru.

(2) This Order applies in relation to Wales.

(3) Daw'r Gorchymyn hwn i rym ar 30 Mehefin 2018.

(3) This Order comes into force on 30 June 2018.
