**ROAD TRAFFIC, WALES**

**The A4042 Trunk Road (Edlogan  
Way Roundabout, Cwmbran,  
Torfaen) (Temporary Prohibition of  
Vehicles) Order 2018**

*Made* 20 July 2018

*Coming into force* 30 July 2018

The Welsh Ministers, as traffic authority for the relevant length of the A4042 Trunk Road, are satisfied that traffic on specified lengths of the trunk road should be prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984<sup>(1)</sup>, make this Order.

**Title, Commencement and Interpretation**

**1.** The title of this Order is the A4042 Trunk Road (Edlogan Way Roundabout, Cwmbran, Torfaen) (Temporary Prohibition of Vehicles) Order 2018 and it comes into force on 30 July 2018.

**2.—(1)** In this Order:

By virtue of S.I. 1999/672, and section 162 of, and paragraph 30 of Schedule 11 to, the Government of Wales Act 2006(c.32), these powers are now exercisable by the Welsh Ministers in relation to Wales.

“exempted vehicle” (“*cerbyd esempt*”) means any vehicle being used for the purposes described in section 87 of the Road Traffic Regulation Act 1984 Act(2) or in in connection with the works giving rise to this Order;

“the trunk road” (“*y gefnffordd*”) means the A4042 Newport to Shrewsbury trunk road;

“works period” (“*cyfnod y gwaith*”) means the period commencing at 20:00 on the 30 July 2018 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

### **Prohibition**

3. No person may, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed on the length of the trunk road specified in the Schedule.

### **Application**

4. The prohibition in article 3 applies only during such times and to such extent as indicated by traffic signs.

### **Duration of this Order**

5. The maximum duration of this Order is 12 months.

## **SCHEDULE**

### **Temporary Prohibition of Vehicles**

That length of the northbound and southbound carriageways of the trunk road from a point 68 metres southeast of the centre point of the Cwmbran roundabout to a point 35 metres northeast of the centrepoint of the Turnpike roundabout, including the circulatory carriageway of the Edlogan Way roundabout.
