**ROAD TRAFFIC, WALES**

**The A470 Trunk Road (South of  
Llangurig, Powys) (Temporary  
Prohibition of Vehicles) Order 2019**

*Made* 24 June 2019

*Coming into force* 3 July 2019

The Welsh Ministers, as traffic authority for the A470 Trunk Road, are satisfied that traffic on a specified length of the trunk road should be prohibited because of works proposed on or near the roads.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984<sup>(1)</sup>, make this Order.

**Title, Commencement and Interpretation**

**1.** The title of this Order is the A470 Trunk Road (South of Llangurig, Powys) (Temporary Prohibition of Vehicles) Order 2019 and it comes into force on 3 July 2019.

**2. In this Order:**

“exempted vehicle” (“*cerbyd esempt*”) means any vehicle being used for the purposes described in section 87 of the Road Traffic Regulation Act 1984 Act(2) or in connection with the works giving rise to this Order;

“the trunk road” (“*y gefnffordd*”) means the A470 Cardiff to Llangurig trunk road that extends from a point 513 metres northwest of its junction at Dolfach Uchaf to the centre point of Llangurig Roundabout in the County of Powys;

“works period” (“*cyfnod y gwaith*”) means the period commencing at 18:00 hours on the 3 July 2019 and ending when the temporary traffic signs are permanently removed.

**Prohibition**

**3.** No person may, during the works period, drive any vehicle, other than an exempted vehicle, on the length of the trunk road.

**Application**

**4.** The prohibition in article 3 applies only during such times and to such extent as indicated by traffic signs.

**Duration of this Order**

**5.** The maximum duration of this Order is 18 months.
