Mae Gweinidogion Cymru yn gwneud y Rheoliadau hyn sy'n dirymu'r terfyn cyflymder uchaf o 50 milltir yr awr ar gerbyttffordd tua'r gorllewin traffordd yr M4 yn Rogiet yn Sir Fynwy sy'n ymestyn o bwynt 800 metr i'r dwyrain o linell ganol trosbont Station Road hyd at bwynt 752 o fetrau i'r gorllewin o linell ganol trosbont Station Road. O ganlyniad, bydd y terfyn cyflymder cenedlaethol yn gymwys i'r gerbyttffordd a enwyd pan ddaw'r Rheoliadau hyn i rym.

Ni luniwyd asesiad effaith rheoleiddiol llawn ar gyfer yr offeryn hwn oherwydd ni fydd y Rheoliadau hyn yn cael unrhyw effaith ar gostau busnes.

EXPLANATORY NOTE

(This note is not part of the Regulations)

The Welsh Ministers make these Regulations which revoke the maximum speed limit of 50 miles per hour on the westbound carriageway of the M4 motorway at Rogiet in the County of Monmouthshire which extends from a point 800 metres east of the centre line of Station Road overbridge to a point 752 metres west of the centre line of Station Road overbridge. In consequence, the national speed limit will apply to the said carriageway upon the coming into force of these Regulations.

A full regulatory impact assessment has not been produced for this instrument as these Regulations have no impact on the costs of business.

Mae Gweinidogion Cymru, drwy arfer y pwerau a roddir iddynt gan adran 17(2), (3) a (3ZAA) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1), ac ar ôl ymgynghori ag unrhyw sefydliadau cynrychioliadol y tybiwyd eu bod yn briodol yn unol ag adran 134(10) o'r Ddeddf honno, yn gwneud y Rheoliadau a ganlyn.

The Welsh Ministers, in exercise of the powers conferred on them by section 17(2), (3) and (3ZAA) of the Road Traffic Regulation Act 1984(1), and after consultation with such representative organisations as were thought fit in accordance with section 134(10) of that Act, make the following Regulations.

1. Enw'r Rheoliadau hyn yw Rheoliadau Rheoliadau Traffordd yr M4 (Man Casglu Tollau Rogiet, Sir Fynwy) (Terfyn Cyflymder 50 mya) 2010 (Dirymu) 2019 a deuant i rym ar 31 Hydref 2019.

Title and commencement

1. The title of these Regulations is the M4 Motorway (Rogiet Toll Plaza, Monmouthshire) (50 mph Speed Limit) Regulations 2010 (Revocation) Regulations 2019 and they come into force on 31 October 2019.

Dirymu

2. Mae Rheoliadau Traffordd yr M4 (Man Casglu Tollau Rogiet, Sir Fynwy) (Terfyn Cyflymder 50 mya) 2010(2) wedi eu dirymu.

Revocation

2. The M4 Motorway (Rogiet Toll Plaza, Monmouthshire) (50 mph Speed Limit) Regulations 2010(2) are revoked.
