EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations are made in exercise of the power conferred by paragraph 1(1) of Schedule 2 and paragraph 21 of Schedule 7 to the European Union (Withdrawal) Act 2018 (c. 16) in order to address failures of retained EU law to operate effectively and other deficiencies arising from the withdrawal of the United Kingdom from the European Union.

These Regulations make amendments to legislation relating to food and horticulture.

Mae rheoliad 2 yn mewnosod darpariaeth drosiannol yn Rheoliadau Marchnata Cynnyrch Garddwriaethol Ffres (Cymru) 2009. Effaith y ddarpariaeth drosiannol honno yw na fydd person yn cyflawni trosedd mewn perthynas â methiant i gydymffurfio ag Erthygl 7 o Reoliad Gweithredu'r Comisiwn (EU) 543/2011 o dan amgylchiadau penodedig penodol.

Mae rheoliad 3 yn diwygio Rheoliadau Wyau a Chywion (Cymru) 2010 (“Rheoliadau 2010”), sy’n darparu ar gyfer gorfodi a gweithredu safonau marchnata sy’n gymwys i wyau deor, cywion dofednod buarth fferm, ac wyau yn eu plisgyn ar gyfer eu bwyta.

Mae rheoliad 3(2) yn mewnosod diffiniad o “trydedd wlad” yn rheoliad 3(1) o Reoliadau 2010. Mae rheoliad 3(3) a (4) yn diwygio’r Atodlenni i Reoliadau 2010 er mwyn dileu cyfeiriadau at ddeddfwriaeth yr UE na fydd yn bodoli mwyach ar ôl y diwrnod ymadael o ganlyniad i ymadawiad y Deyrnas Unedig â'r Undeb Ewropeaidd. Mae rheoliad 3(5) yn dileu cyfeiriad at “cenedlaethol” o Atodlen 3 i Reoliadau 2010 er mwyn cyd-fynd â newidiadau sy’n cael eu gwneud i gyfraith arall yr UE a ddargedwir.

Mae rheoliad 4 yn diwygio Rheoliadau Cig Dofednod (Cymru) 2011 (“Rheoliadau 2011”), sy’n darparu ar gyfer gorfodi a gweithredu safonau marchnata sy’n gymwys i gig dofednod. Mae'r diwygiad yn mewnosod diffiniad o “trydedd wlad” yn rheoliad 2(1) o Reoliadau 2011.

Mae rheoliad 5 yn diwygio Rheoliadau Bwyd (Diwygiadau Amrywiol) (Cymru) (Ymadael â'r UE) 2019. Mae'r diwygiad o dan sylw, yn ei dro, yn gwneud newidiadau i Reoliadau Labelu Cig Eidion a Chig Llo (Cymru) 2019 fel nad yw person yn cyflawni trosedd sy'n ymwneud â methiant i gydymffurfio ag Erthygl 2(2)(b) o Reoliad y Comisiwn (EC) 1825/2000 o dan amgylchiadau penodedig penodol.

Mae rheoliad 6 yn diwygio Rheoliadau Gwybodaeth am Fwyd (Cymru) (Diwygio) (Ymadael â'r UE) 2019. Mae'r diwygiadau dan sylw yn eu tro yn gwneud newidiadau i Reoliadau Gwybodaeth am Fwyd (Cymru) 2014. Mae'r diwygiadau cyntaf yn dileu cyfeiriadau at stociau a ddelir “o fewn y cyfnod cyn y diwrnod ymadael” ac “ar y diwrnod ymadael”. Mae rheoliad 6(3) yn mewnosod “caniateir marchnata cynhyrchion eraill y mae paragraff (3) yn gymwys iddynt hyd nes diwedd y cyfnod perthnasol” sy’n sicrhau y caniateir parhau i farchnata cynhyrchion enw bwyd gwarchodedig/dynodiad daearyddol nad ydynt yn winoedd am dair blynedd o'r diwrnod drannoeth y diwrnod ymadael.

Regulation 2 inserts a transitional provision into the Marketing of Fresh Horticultural Produce (Wales) Regulations 2009. The effect of that transitional provision is that a person will not commit an offence in relation to a failure to comply with Article 7 of Commission Implementing Regulation (EU) 543/2011 in certain specified circumstances.

Regulation 3 amends the Eggs and Chicks (Wales) Regulations 2010 (“the 2010 Regulations”), which make provision for the enforcement and execution of marketing standards applicable to eggs for hatching, farmyard poultry chicks, and eggs in shell for human consumption.

Regulation 3(2) inserts a definition of “third country” into regulation 3(1) of the 2010 Regulations. Regulation 3(3) and (4) amends the Schedules to the 2010 Regulations to remove references to EU legislation which will no longer exist after exit day as a result of the withdrawal of the United Kingdom from the European Union. Regulation 3(5) removes a reference to “national” from Schedule 3 to the 2010 Regulations to align with changes being made to other retained EU law.

Regulation 4 amends the Poultrymeat (Wales) Regulations 2011 (“the 2011 Regulations”), which make provision for the enforcement and execution of marketing standards applicable to poultrymeat. The amendment inserts a definition of “third country” into regulation 2(1) of the 2011 Regulations.

Regulation 5 amends the Food (Miscellaneous Amendments) (Wales) (EU Exit) Regulations 2019. The amendment in question, in turn, makes changes to the Beef and Veal Labelling (Wales) Regulations 2019 so that a person does not commit an offence relating to a failure to comply with Article 2(2)(b) of Commission Regulation (EC) 1825/2000 in certain specified circumstances.

Regulation 6 amends the Food Information (Wales) (Amendment) (EU Exit) Regulations 2019. The amendments in question in turn make changes to the Food Information (Wales) Regulations 2014. The first amendments remove references to stocks held “within the period before exit day” and “as at exit day”. Regulation 6(3) inserts “other products to which paragraph (3) applies may continue to be marketed until the end of the relevant period” which ensures non wine protected food name/geographical indicator products may continue to be marketed for three years from the day after exit day.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

The Welsh Ministers, in exercise of the power conferred by paragraph 1(1) of Schedule 2 and paragraph 21 of Schedule 7 to the European Union (Withdrawal) Act 2018(1), make the following Regulations.

Mae Gweinidogion Cymru o'r farn, oherwydd brys, fod angen gwneud y Rheoliadau hyn heb osod drafft o'r offeryn gerbron Cynulliad Cenedlaethol Cymru, na chymeradwyo'r drafft hwnnw drwy benderfyniad ganddo.

Yn unol â pharagraff 4(a) o Atodlen 2 i Ddeddf yr Undeb Ewropeaidd (Ymadael) 2018, mae Gweinidogion Cymru wedi ymgynghori â'r Ysgrifennydd Gwladol yngylch diwygio Rheoliadau Bwyd (Diwygiadau Amrywiol) (Cymru) (Ymadael â'r UE) 2019(1) a diwygio Rheoliadau Gwybodaeth am Fwyd (Cymru) (Diwygio) (Ymadael â'r UE) 2019(2).

Fel sy'n ofynnol gan Erthygl 9 o Reoliad (EC) Rhif 178/2002 Senedd Ewrop a'r Cyngor sy'n gosod egwyddorion a gofynion cyffredinol cyfraith bwyd, yn sefydlu Awdurdod Diogelwch Bwyd Ewrop ac yn gosod gweithdrefnau o ran materion diogelwch bwyd(3), ymgynghorwyd yn agored ac yn dryloyw â'r cyhoedd wrth lunio'r Rheoliadau hyn o ran diwygio Rheoliadau Marchnata Cynnyrch Garddwriaethol Ffres (Cymru) 2009(4), Rheoliadau Wyau a Chywion (Cymru) 2010(5), Rheoliadau Cig Dofednod (Cymru) 2011(6), Rheoliadau Gwybodaeth am Fwyd (Cymru) (Diwygio) (Ymadael â'r UE) 2019 a Rheoliadau Bwyd (Diwygiadau Amrywiol) (Cymru) (Ymadael â'r UE) 2019.

Enwi a chychwyn

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Materion Gwledig (Diwygiadau Amrywiol) (Cymru) (Ymadael â'r UE) (Rhif 3) 2019.

(2) Ac eithrio rheoliadau 5 a 6, a ddaw i rym yn union cyn y diwrnod ymadael, daw'r Rheoliadau hyn i rym ar y diwrnod ymadael.

The Welsh Ministers are of the opinion that, by reason of urgency, it is necessary to make these Regulations without a draft of the instrument being laid before, and approved by resolution of, the National Assembly for Wales.

In accordance with paragraph 4(a) of Schedule 2 to the European Union (Withdrawal) Act 2018, the Welsh Ministers have consulted the Secretary of State with regard to the amendment of the Food (Miscellaneous Amendments) (Wales) (EU Exit) Regulations 2019(1) and the amendment of the Food Information (Wales) (Amendment) (EU Exit) Regulations 2019(2).

As required by Article 9 of Regulation (EC) No 178/2002 of the European Parliament and of the Council laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety(3) there has been open and transparent public consultation during the preparation of these Regulations with regard to the amendment of the Marketing of Fresh Horticultural Produce (Wales) Regulations 2009(4), the Eggs and Chicks (Wales) Regulations 2010(5), the Poultrymeat (Wales) Regulations 2011(6), the Food Information (Wales) (Amendment) (EU Exit) Regulations 2019 and the Food (Miscellaneous Amendments) (Wales) (EU Exit) Regulations 2019.

Title and commencement

1.—(1) The title of these Regulations is the Rural Affairs (Miscellaneous Amendments) (Wales) (EU Exit) (No. 3) Regulations 2019.

(2) Save for regulations 5 and 6 which come into force immediately before exit day, these Regulations come into force on exit day.

Amendment of the Marketing of Fresh Horticultural Produce (Wales) Regulations 2009

2. In the Marketing of Fresh Horticultural Produce (Wales) Regulations 2009, after regulation 22 insert—

“Transitional provisions: withdrawal from the EU

23.—(1) Regulation 4 does not apply in relation to a failure to comply with Article 7 of Commission Implementing Regulation 543/2011 if the matter constituting the alleged contravention—

- (a) relates to a product that was placed on the market before the end of the period of 21 months beginning on the day on which exit day falls, and
- (b) would not have constituted a contravention of that Regulation as it applied immediately before exit day.

(2) An authorised officer must not exercise the powers under regulation 11(1) in relation to a failure to comply with Article 7 of Commission Implementing Regulation 543/2011 if the matter constituting the alleged contravention—

- (a) relates to a product that was placed on the market before the end of the period of 21 months beginning on the day on which exit day falls, and
- (b) would not have constituted a contravention of that Regulation as it applied immediately before exit day.”

Amendment of the Eggs and Chicks (Wales) Regulations 2010

3.—(1) The Eggs and Chicks (Wales) Regulations 2010 are amended as follows.

(2) In regulation 3(1), at the appropriate place, insert the following definition—

- ““third country” (“trydedd wlad”) means any country or territory other than—
- (a) the United Kingdom;
 - (b) the Bailiwick of Guernsey;
 - (c) the Bailiwick of Jersey;
 - (d) the Isle of Man.”

(4) Yn Atodlen 2, yn Rhan 2, yn y tabl—

5. Yn Rheoliadau Bwyd (Diwygiadau Amrywiol) (Cymru) (Ymadael â'r UE) 2019, yn rheoliad 4(2), yn lle is-baragraff (b) rhodder—

“(b) ar ôl paragraff (3) mewnosoder—

“(4) Nid yw paragraff (1)(b)(ii) yn gymwys mewn perthynas â methiant i gydymffurfio ag Erthygl 2(2)(b) o Reoliad (EC) Rhif 1825/2000 Senedd Ewrop a'r Cyngor—

- (a) os yw'r mater sy'n ffurfi'o'r toriad honedig yn ymneud â chynnrych a osodwyd ar y farchnad cyn diwedd y cyfnod o 21 o fisioedd sy'n dechrau ar y diwrnod y mae'r diwrnod ymadael yn digwydd, a

(3) In Schedule 1, in Part 2, in the table, omit row 6.

(4) In Schedule 2, in Part 2, in the table—

(a) in row 2, in column 2, omit “Article 3 of Commission Regulation (EC) No 589/2008”, and

(b) omit rows 18 to 20.

(5) In Schedule 3, in the table, in row 1, in column 3, omit “national”.

Amendment of the Poultrymeat (Wales) Regulations 2011

4. In the Poultrymeat (Wales) Regulations 2011, in regulation 2(1), at the appropriate place, insert the following definition—

““third country” (“trydedd wlad”) means any country or territory other than—

- (a) the United Kingdom;
- (b) the Bailiwick of Guernsey;
- (c) the Bailiwick of Jersey;
- (d) the Isle of Man.”

Amendment of the Food (Miscellaneous Amendments) (Wales) (EU Exit) Regulations 2019

5. In the Food (Miscellaneous Amendments) (Wales) (EU Exit) Regulations 2019, in regulation 4(2), for sub-paragraph (b) substitute—

“(b) after paragraph (3) insert—

“(4) Paragraph (1)(b)(ii) does not apply in relation to a failure to comply with Article 2(2)(b) of Regulation (EC) No 1825/2000 of the European Parliament and the Council if the matter constituting the alleged contravention—

- (a) relates to a product that was placed on the market before the end of the period of 21 months beginning on the day on which exit day falls, and
- (b) would not have constituted a contravention of that Regulation as it applied immediately before exit day.””

Diwygio Rheoliadau Gwybodaeth am Fwyd (Cymru) (Diwygio) (Ymadael â'r UE) 2019

Amendment of the Food Information (Wales) (Amendment) (EU Exit) Regulations 2019

6.—(1) Regulation 2 of the Food Information (Wales) (Amendment) (EU Exit) Regulations 2019 is amended as follows.

(2) For the words to be inserted into the Food Information (Wales) Regulations 2014(1) as regulation 15(2) substitute—

“(2) Products to which paragraph (1) applies may continue to be marketed until stocks are exhausted.”

(3) For the words to be inserted into the Food Information (Wales) Regulations 2014 as regulation 15(4) substitute—

“(4) Wine products to which paragraph (3) applies may continue to be marketed until stocks are exhausted.”

(4A) Other products to which paragraph (3) applies may continue to be marketed until the end of the relevant period.”


