These Regulations amend paragraph 9(3)(a) of Schedule 7 to the Transmissible Spongiform Encephalopathies (Wales) Regulations 2018 (S.I. 2018/968 (W. 195)).

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

The Transmissible Spongiform Encephalopathies (Wales) (Amendment) Regulations 2019

Made 25 February 2019

Laid before the National Assembly for Wales
26 February 2019

Coming into force 28 March 2019

The Welsh Ministers have been designated(1) for the purposes of section 2(2) of the European Communities Act 1972(2) in relation to measures in the veterinary and phytosanitary fields for the protection of public health.

The Welsh Ministers make these Regulations under the powers conferred by section 2(2) of, and paragraph 1A of Schedule 2 to, the European Communities Act 1972(3).

Title and commencement

1.—(1) The title of these Regulations is the Transmissible Spongiform Encephalopathies (Wales) (Amendment) Regulations 2019.
