Mae'r Rheoliadau hyn, ac eithrio rheoliad 6, wedi eu gwneud drwy arfer y pwerau a roddir i Weinidogion Cymru gan baragraff 1(1) o Atodlen 2 a pharagraff 21(b) o Atodlen 7 i Ddeddf yr Undeb Ewropeaidd (Ymadael) 2018 (p. 16), er mwyn ymdrin ag unrhyw fethiant yng nghyfraith yr UE a ddargedwir i weithredu'n effeithiol a diffygion eraill sy'n deillio o ymadawiad y Deyrnas Unedig â'r Undeb Ewropeaidd.

These Regulations, other than regulation 6, are made in exercise of the powers conferred on the Welsh Ministers by paragraph 1(1) of Schedule 2 and paragraph 21(b) of Schedule 7 to the European Union (Withdrawal) Act 2018 (c. 16) in order to address failures of retained EU law to operate effectively and other deficiencies arising from the withdrawal of the United Kingdom from the European Union.

Mae rheoliad 6 wedi ei wneud o dan adran 16 o Ddeddf Diogelwch Bwyd 1990 (p. 16) i ddiwygio Rheoliadau Mêl (Cymru) 2015 i osod y dull dadansoddi y mae'n rhaid i awdurdodau bwyd ei ddefnyddio i wirio cydymffurfedd â gofynion y Rheoliadau hynny.

Regulation 6 is made under section 16 of the Food Safety Act 1990 (c. 16) to amend the Honey (Wales) Regulations 2015 to set the method of analysis that food authorities must use to verify compliance with those Regulations' requirements.

Mae'r Rheoliadau hyn yn gwneud diwygiadau i is-ddeddfwriaeth sy'n gymwys yng Nghymru ym maes cyfansoddiad a labelu bwyd.

These Regulations make amendments to subordinate legislation applying in Wales in the field of food composition and labelling.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

Mae Gweinidogion Cymru yn gwneud y Rheoliadau hyn drwy arfer y pwerau a roddir gan baragraff 1(1) o Atodlen 2 a pharagraff 21(b) o Atodlen 7 i Ddeddf yr Undeb Ewropeaidd (Ymadael) 2018(1) a chan adran 16(1)(a) ac (e) o Ddeddf Diogelwch Bwyd 1990(2).

Mae gofynion paragraff 4(2) o Atodlen 7 i Ddeddf yr Undeb Ewropeaidd (Ymadael) 2018 (sy'n ymwneud â gweithdrefn graffu briodol Cynulliad Cenedlaethol Cymru ar gyfer y Rheoliadau hyn) wedi eu bodloni.

Fel sy'n ofynnol gan Erthygl 9 o Reoliad (EC) Rhif 178/2002 Senedd Ewrop a'r Cyngor sy'n gosod egwyddorion cyffredinol a gofynion cyfraith bwyd, yn sefydlu Awdurdod Diogelwch Bwyd Ewrop ac yn gosod gweithdrefnau o ran materion diogelwch bwyd(3), ymgynghorwyd yn agored ac yn dryloyw â'r cyhoedd wrth lunio'r Rheoliadau hyn.

Enwi, cymhwyso a chychwyn

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Safonau a Labelu Bwyd (Diwygiadau Amrywiol) (Cymru) (Ymadael â'r UE) 2019.

(2) Mae'r Rheoliadau hyn yn gymwys o ran Cymru.

(3) Daw'r Rheoliadau hyn i rym ar y diwrnod ymadael.

Rheoliadau Bwyd (Marcio Lotiau) 1996

2.—(1) Mae Rheoliadau Bwyd (Marcio Lotiau) 1996(4) wedi eu diwygio fel a ganlyn.

(2) Yn rheoliad 2, hepgorer y diffiniad o "first seller established within the European Union".

(3) Yn rheoliad 3(2)(a), yn lle "European Union" rhodder "United Kingdom".

The Welsh Ministers make these Regulations in exercise of the powers conferred by paragraph 1(1) of Schedule 2 and paragraph 21(b) of Schedule 7 to the European Union (Withdrawal) Act 2018(1) and by section 16(1)(a) and (e) of the Food Safety Act 1990(2).

The requirements of paragraph 4(2) of Schedule 7 to the European Union (Withdrawal) Act 2018 (relating to the appropriate National Assembly for Wales scrutiny procedure for these Regulations) have been satisfied.

As required by Article 9 of Regulation (EC) No 178/2002 of the European Parliament and of the Council laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety(3) there has been open and transparent public consultation during the preparation of these Regulations.

Title, application and commencement

1.—(1) The title of these Regulations is the Food Standards and Labelling (Miscellaneous Amendments) (Wales) (EU Exit) Regulations 2019.

(2) These Regulations apply in relation to Wales.

(3) These Regulations come into force on exit day.

The Food (Lot Marking) Regulations 1996

2.—(1) The Food (Lot Marking) Regulations 1996(4) are amended as follows.

(2) In regulation 2, omit the definition of "first seller established within the European Union".

(3) In regulation 3(2)(a), for "European Union" substitute "United Kingdom".

3.—(1) Mae Rheoliadau Brasterau Taenadwy (Safonau Marchnata) a Llaeth a Chynhyrchion Llaeth (Diogelu Dynodiadau) (Cymru) 2008(1) wedi eu diwygio fel a ganlyn.

(2) Yn rheoliad 2(1)—

- (a) hepgorer y diffiniad o “darpariaeth UE”;
- (b) yn y lle priodol, mewnosoder—
“ystyr “darpariaeth benodedig” (“*specified provision*”) yw darpariaeth y cyfeirir ati yn rheoliad 6(2);”.

(3) Yn rheoliad 5, yn lle “UE” rhodder “penodedig”.

(4) Yn rheoliad 6—

- (a) ym mharagraff (1)(b), yn lle “UE” rhodder “benodedig”;
- (b) ym mharagraff (2), yn y geiriau o flaen isbaragraff (a), yn lle “UE” rhodder “penodedig”.

(5) Yn rheoliad 7(2), yn lle “UE” rhodder “penodedig”.

Rheoliadau Labelu Pysgod (Cymru) 2013

4.—(1) Mae Rheoliadau Labelu Pysgod (Cymru) 2013(2) wedi eu diwygio fel a ganlyn.

(2) Yn rheoliad 2—

- (a) hepgorer y diffiniad o “Rheoliadau’r UE”.
- (b) yn y lle priodol, mewnosoder—
“ystyr “y Rheoliadau penodedig” (“*the specified Regulations*”) yw Rheoliad 1224/2009, Rheoliad 404/2011 a Rheoliad 1379/2013;”.
- (c) ym mharagraff (2)(a), yn lle “o Reoliadau’r UE” rhodder “o’r Rheoliadau penodedig” ac yn lle “at Reoliadau’r UE” rhodder “at y Rheoliadau penodedig” ac ym mharagraff (2)(b), yn lle “o Reoliadau’r UE” rhodder “o’r Rheoliadau penodedig” ac yn lle “yn Rheoliadau’r UE” rhodder “yn y Rheoliadau penodedig”.

The Spreadable Fats (Marketing Standards) and the Milk and Milk Products (Protection of Designations) (Wales) Regulations 2008

3.—(1) The Spreadable Fats (Marketing Standards) and the Milk and Milk Products (Protection of Designations) (Wales) Regulations 2008(1) are amended as follows.

(2) In regulation 2(1)—

- (a) omit the definition of “EU provision”;
- (b) at the appropriate place, insert—
““specified provision” (“*darpariaeth benodedig*”) means a provision referred to in regulation 6(2);”.

(3) In regulation 5, for “EU” substitute “specified”.

(4) In regulation 6—

- (a) in paragraph (1)(b), for “EU” substitute “specified”;
- (b) in paragraph (2), in the words before subparagraph (a), for “EU” substitute “specified”.

(5) In regulation 7(2), for “EU” substitute “specified”.

The Fish Labelling (Wales) Regulations 2013

4.—(1) The Fish Labelling (Wales) Regulations 2013(2) are amended as follows.

(2) In regulation 2—

- (a) omit the definition of “the EU Regulations”;
- (b) at the appropriate place, insert—
““the specified Regulations” (“*y Rheoliadau Penodedig*”) means Regulation 1224/2009, Regulation 404/2011 and Regulation 1379/2013.”
- (c) in paragraph (2)(a) and (b), for “EU”, in each place it occurs, substitute “specified”.

5. Yn Atodlen 5 i Reoliadau Gwybodaeth am Fwyd (Cymru) 2014(1), yn Rhan 2, hepgorer y cofnodion sy’n dwyn y rhifau 33 a 34.

Rheoliadau Mêl (Cymru) 2015

6. Yn Rheoliadau Mêl (Cymru) 2015(2), ar ôl rheoliad 18 mewnosoder—

“Dulliau dadansoddi

18A. Wrth gyflawni ei rwymedigaethau o dan reoliad 18, rhaid i awdurdod bwyd, pryd bynnag y bo’n bosibl, ddefnyddio dull dadansoddi a gymeradwyir gan y Codex Alimentarius, neu ddull dadansoddi arall sydd wedi ei ddilysu ac a gydnabyddir yn rhyngwladol, i wirio cydymffurfedd â darpariaethau’r Rheoliadau hyn.”

Rheoliadau Gwlad Tarddiad Cigoedd Penodol (Cymru) 2015

7. Yn rheoliad 3(a) o Reoliadau Gwlad Tarddiad Cigoedd Penodol (Cymru) 2015(3), yn lle “aelod-wladwriaeth neu drydedd wlad” rhodder “wlad unigol”.

(3) In regulation 4—

- (a) in paragraph (3), for “and (5)”, in the second place it occurs, substitute “, (5) to (7) and (9)”;
- (b) in paragraph (7), for “the sterling equivalent of 50 euros” substitute “£45”.

(4) In regulation 5(3), in the definition of “operator”, for “EU” substitute “specified”.

The Food Information (Wales) Regulations 2014

5. In Schedule 5 to the Food Information (Wales) Regulations 2014(1), in Part 2, omit entry numbers 33 and 34.

The Honey (Wales) Regulations 2015

6. In the Honey (Wales) Regulations 2015(2), after regulation 18 insert—

“Methods of analysis

18A. In carrying out its obligations under regulation 18, a food authority must, whenever possible, use a method of analysis approved by the Codex Alimentarius, or another internationally recognised validated method of analysis, to verify compliance with the provisions of these Regulations.”

The Country of Origin of Certain Meats (Wales) Regulations 2015

7. In regulation 3(a) of the Country of Origin of Certain Meats (Wales) Regulations 2015(3), for “member State or third” substitute “single”.
