**EXPLANATORY NOTE**

(*This note is not part of the Order*)

This Order designates the area described in the Schedule to this Order as a civil enforcement area for parking contraventions and a special enforcement area for the purpose of Part 6 of the Traffic Management Act 2004. This Order enables Blaenau Gwent County Borough Council to enforce parking contraventions within the area described in the Schedule to this Order through a civil law regime, as opposed to enforcement by police or traffic wardens in a criminal law context.

This Order is made by the Welsh Ministers(1) in  
exercise of the powers conferred on the National  
Assembly for Wales by paragraph 8(1) of Schedule 8  
and paragraph 3(1) of Schedule 10 to the Traffic  
Management Act 2004(2).

Blaenau Gwent County Borough Council has applied  
to the Welsh Ministers for an Order to be made under  
these powers in respect of part of that Council's area.

The Welsh Ministers have consulted the chief officer  
of Gwent Police in accordance with the requirements  
of paragraph 8(3) of Schedule 8 and paragraph 3(4) of  
Schedule 10 to the Traffic Management Act 2004.


