EXPLANATORY NOTE

(This note is not part of the Order)

This Order designates the area described in the Schedule to this Order as a civil enforcement area for parking contraventions and a special enforcement area for the purpose of Part 6 of the Traffic Management Act 2004. This Order enables the Council of the County Borough and City of Newport to enforce parking contraventions within the area described in the Schedule to this Order through a civil law regime, as opposed to enforcement by police or traffic wardens in a criminal law context.

Mae'r Gorchymyn hwn wedi ei wneud gan Weinidogion Cymru(1) drwy arfer y pwerau a roddir i Gynulliad Cenedlaethol Cymru gan baragraff 8(1) o Atodlen 8 a pharagraff 3(1) o Atodlen 10 i Ddeddf Rheoli Traffig 2004(2).

This Order is made by the Welsh Ministers(1) in exercise of the powers conferred on the National Assembly for Wales by paragraph 8(1) of Schedule 8 and paragraph 3(1) of Schedule 10 to the Traffic Management Act 2004(2).

Mae Cyngor Bwrdeistref Sirol a Dinas Casnewydd wedi gwneud cais i Weinidogion Cymru i Orchymyn gael ei wneud o dan y pwerau hyn mewn cysylltiad â rhan o ardal y Cyngor hwnnw.

The Council of the County Borough and City of Newport has applied to the Welsh Ministers for an Order to be made under these powers in respect of part of that Council's area.

Mae Gweinidogion Cymru wedi ymgynghori â phrif swyddog Heddlu Gwent yn unol â gofynion paragraff 8(3) o Atodlen 8 a pharagraff 3(4) o Atodlen 10 i Ddeddf Rheoli Traffig 2004.

The Welsh Ministers have consulted the chief officer of Gwent Police in accordance with the requirements of paragraph 8(3) of Schedule 8 and paragraph 3(4) of Schedule 10 to the Traffic Management Act 2004.

The functions of the National Assembly for Wales under the Traffic Management Act 2004 were transferred to the Welsh Ministers by virtue of section 162 of, and paragraph 30 of Schedule 11 to, the Government of Wales Act 2006 (c. 32).

2. The Welsh Ministers designate the area described in the Schedule to this Order as—

- (a) a civil enforcement area for parking contraventions; and
- (b) a special enforcement area.

The area of the County Borough and City of Newport (“the County Borough and City”) with the exception of—

- (a) the length of the M4 Motorway within the County Borough and City, from the boundary with the City and County of Cardiff to the boundary with the County of Monmouthshire, including its exit and entry slip roads;
- (b) the length of the A48 Motorway within the County Borough and City, from the boundary with the City and County of Cardiff to the junction with the M4 Motorway;
- (c) the length of the A449 Trunk Road within the County Borough and City, from the junction with the M4 Motorway to the boundary with the County of Monmouthshire; and
- (d) the length of the A4042 Trunk Road within the County Borough and City, from the junction with the M4 Motorway to the boundary with the County Borough of Torfaen.
