ynghylch anghydraddoldebau economaidd-
gymdeithasol ("y ddyletswydd"). Caiff Gweinidogion
Cymru, o dan adran 2(4)(a) o Ddeddf 2010,
ychwanegu awdurdod perthnasol at y rhestr o
awdurdodau sy'n ddarostyngedig i'r ddyletswydd.
Ystyr "relevant authority" yw awdurdod Cymreig
datganoledig (o fewn yr ystyr a roddir i "devolved
Welsh authority" gan adran 157A o Ddeddf
Llywodraeth Cymru 2006) y mae ei swyddogaethau'n
cyfateb i swyddogaethau awdurdod a bennir am y tro
yn is-adran (3) neu y cyfeirir ato yn is-adran (4) o

The Equality Act 2010 (Authorities
subject to a duty regarding Socio-
economic Inequalities) (No. 2)
(Wales) Regulations 2021

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations are connected with Regulations
which establish certain corporate joint committees
under Part 5 of the Local Government and Elections
(Wales) Act 2021.

Section 1 of the Equality Act 2010 ("the 2010 Act")
provides the list of authorities that are subject to a
public sector duty regarding socio-economic
inequalities ("the duty"). The Welsh Ministers may,
under section 2(4)(a) of the 2010 Act, add a relevant
authority to the list of authorities that are subject to the
duty. "Relevant authority" means a devolved Welsh
authority (within the meaning given by section 157A
of the Government of Wales Act 2006) whose
functions correspond or are similar to those of an
authority for the time being specified in subsection (3)
or referred to in subsection (4) of section 1 of the 2010
Act.

Mae'r Rheoliadau hyn yn arfer y pŵer yn adran 2(4)(a) o Ddeddf 2010 i ddiwygio adran 1 o'r Ddeddf honno er mwyn ychwanegu cyd-bwyllgorau corfforedig at y rhestr o awdurdodau perthnasol sy'n ddarostyngedig i'r ddyletswydd.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau sy'n sefydlu cyd-bwyllgorau corfforedig a rheoliadau cysylltiedig. O ganlyniad, lluniwyd asesiad effaith rheoleiddiol. Gellir cael copi oddi wrth: Yr Is-adran Cyllid Strategol Llywodraeth Leol, Llywodraeth Cymru, Parc Cathays, Caerdydd, CF10 3NQ.

These Regulations exercise the power in section 2(4)(a) of the 2010 Act to amend section 1 of that Act in order to add corporate joint committees to the list of relevant authorities subject to the duty.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to the Regulations which establish corporate joint committees and connected regulations. As a result, a regulatory impact assessment has been prepared. A copy can be obtained from the Local Government Strategic Finance Division, Welsh Government, Cathays Park, Cardiff, CF10 3NQ.

The Welsh Ministers make the following Regulations
in exercise of the power conferred on them by section
2(4)(a) of the Equality Act 2010(1).

A draft of this instrument has been laid before, and
approved by a resolution of, Senedd Cymru in
accordance with section 209(2), (3)(a) and (6)(2) of
that Act.

Title and commencement

1.—(1) The title of these Regulations is the Equality
Act 2010 (Authorities subject to a duty regarding
Socio-economic Inequalities) (No. 2) (Wales)
Regulations 2021.

paragraph 83(1) and (2) of Schedule 6 to the Wales Act 2017 (c. 4).
(2) The reference in section 209(6) to the National Assembly for Wales
now has effect as a reference to Senedd Cymru, by virtue of section
150A(2) of the Government of Wales Act 2006 (c. 32).

Diwygio Deddf Cydraddoldeb 2010

2. Yn adran 1 o Ddeddf Cydraddoldeb 2010 (y ddyletswydd sector cyhoeddus yngylch anghydraddoldebau economaidd-gymdeithasol), yn is-adran (3A)(1), ar ôl paragraff (b) mewnosoder—

“(ba) a corporate joint committee established by regulations made under Part 5 of the Local Government and Elections (Wales) Act 2021(2);”.

(2) These Regulations come into force on 3 December 2021.

Amendment of the Equality Act 2010

2. In section 1 of the Equality Act 2010 (public sector duty regarding socio-economic inequalities), in subsection (3A)(1), after paragraph (b) insert—

“(ba) a corporate joint committee established by regulations made under Part 5 of the Local Government and Elections (Wales) Act 2021(2);”.
