**EXPLANATORY NOTE**

Mae Mesur Plant a Theuluoedd (Cymru) 2010 (“y Mesur”) yn gwneud darpariaeth ynghylch cyfraniad awdurdodau Cymreig at ddileu tlodi plant yng Nghymru.

The Children and Families (Wales) Measure 2010 (“the Measure”) makes provision about Welsh authorities contributing to the eradication of Child poverty in Wales.

Mae cyd-bwyllgorau corfforedig a sefydlir drwy reoliadau a wneir o dan Ran 5 o Ddeddf Llywodraeth Leol ac Etholiadau (Cymru) 2021 (“y Ddeddf”) yn awdurdodau Cymreig at ddiben y Mesur.

Corporate joint committees established by regulations made under Part 5 of the Local Government and Elections (Wales) Act 2021 (“the Act”) are Welsh authorities for the purpose of the Measure.

Mae'r Rheoliadau hyn yn nodi'r cyfnod amser y mae strategaeth tlodi plant a lunnir gan gyd-bwyllgor corfforedig mewn perthynas ag ef, pa bryd y dylai'r strategaeth gael ei hadnewyddu, pa bryd a sut y dylai'r strategaeth gael ei chyhoeddi a sut y gellir ei harchwilio.

These Regulations set out the period of time to which a child poverty strategy prepared by a corporate joint committee relates, when the strategy should be renewed, when and how the strategy should be published and how it can be inspected.

Mae'r Rheoliadau hyn hefyd yn diwygio Rheoliadau'r Strategaeth Tlodi Plant (Cymru) 2011, drwy ddatgymhwyso'r Rheoliadau hynny i gyd-bwyllgorau corfforedig.

These Regulations also amend the Child Poverty Strategy (Wales) Regulations 2011 by disapplying those Regulations to corporate joint committees.

Mae'r Rheoliadau hyn yn gysylltiedig â rheoliadau a sefydlodd gyd-bwyllgorau corfforedig penodol o dan Ran 5 o'r Ddeddf.

These Regulations are connected with regulations which established certain corporate joint committees under Part 5 of the Act.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Aseidiadau Effaith Rheoleiddiol mewn perthynas â'r rheoliadau sy'n sefydlu cyd-bwyllgorau corfforedig a gorchmynion a rheoliadau cysylltiedig. O ganlyniad, lluniwyd asesiad effaith rheoleiddiol. Gellir cael copi oddi wrth: Yr Is-adran Cyllid Strategol Llywodraeth Leol, Llywodraeth Cymru, Parc Cathays, Caerdydd, CF10 3NQ.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to the regulations which establish corporate joint committees and connected orders and regulations. Mae Gweinidogion Cymru yn gwneud y Rheoliadau a ganlyn drwy arfer y pwerau a roddir iddynt gan adran 5(3) o Fesur Plant a Theuluoedd 2010(1) ac adrannau 84(2)(a) a 174(2) o Ddeddf Llywodraeth Leol ac Etholiadau (Cymru) 2021(2) ("Deddf 2021").

Gosodwyd drafft o'r offeryn hwn gerbron Senedd Cymru ac fe'i cymeradwywyd ganddi drwy benderfyniad yn unol ag adran 174(4) a (5)(l) o Ddeddf 2021(3).

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau'r Strategaeth Tlodi Plant (Cyd-bwyllgorau Corfforedig) (Cymru) 2021.

The Child Poverty Strategy  
(Corporate Joint Committees)  
(Wales) Regulations 2021

*Made at 10.05 a.m. on 1 December 2021*

*Coming into force 3 December 2021*

The Welsh Ministers make the following Regulations in exercise of the powers conferred on them by section 5(3) of the Children and Families (Wales) Measure 2010(1) and sections 84(2)(a) and 174(2) of the Local Government and Elections (Wales) Act 2021(2) ("the 2021 Act").

A draft of this instrument has been laid before, and approved by a resolution of, Senedd Cymru in accordance with section 174(4) and (5)(l) of the 2021 Act(3).

#### **Title and coming into force**

1.—(1) The title of these Regulations is the Child Poverty Strategy (Corporate Joint Committees) (Wales) Regulations 2021.

(2) These Regulations come into force on 3 December 2021.

## Dehongli

### 2. Yn y Rheoliadau hyn—

- (a) ystyr “strategaeth tldi plant” yw strategaeth sy’n nodi pob un o’r pethau a bennir yn adran 2(1) o Fesur Plant a Theuluoedd (Cymru) 2010;
- (b) ystyr “cyd-bwyllgor corfforedig” yw cyd-bwyllgor corfforedig a sefydlir drwy reoliadau a wneir o dan Ran 5 o Ddeddf Llywodraeth Leol ac Etholiadau (Cymru) 2021;
- (c) ystyr “awdurdod lleol” yw cyngor sir neu cyngor bwrdeistref sirol yng Nghymru;
- (d) ystyr “cyfnod y strategaeth” yw’r cyfnod y mae strategaeth tldi plant mewn perthynas ag ef.

### **Cyfnod y strategaeth ar gyfer y strategaeth tldi plant gyntaf a'r strategaethau tldi plant sy'n dilyn**

3.—(1) Cyfnod y strategaeth ar gyfer y strategaeth tldi plant gyntaf a lunnir gan gyd-bwyllgor corfforedig a sefydlir ar 1 Ionawr 2022 neu cyn hynny yw’r cyfnod sy’n dechrau ar 1 Ebrill 2023 ac yn dod i ben ar 31 Mawrth 2026.

(2) Cyfnod y strategaeth ar gyfer y strategaeth tldi plant gyntaf a lunnir gan gyd-bwyllgor corfforedig a sefydlir ar ôl 1 Ionawr 2022 yw’r cyfnod—

- (a) sy’n dechrau ar y dyddiad y cyhoeddir y strategaeth (gweler rheoliad 4(2)), a
- (b) sy’n dod i ben ar 31 Mawrth yn y drydedd flwyddyn galendr yn dilyn y flwyddyn galendr y cyhoeddir y strategaeth ynddi.

(3) Cyfnod y strategaeth ar gyfer strategaethau tldi plant dilynol yw’r cyfnod o dair blynedd sy’n dechrau ar 1 Ebrill yn union ar ôl diwedd cyfnod y strategaeth ar gyfer y strategaeth flaenorol.

### **Amseriad cyhoeddi'r strategaeth tldi plant gyntaf a'r strategaethau tldi plant sy'n dilyn**

4.—(1) Rhaid i gyd-bwyllgor corfforedig a sefydlir ar 1 Ionawr 2022 neu cyn hynny gyhoeddi ei strategaeth tldi plant gyntaf ar 1 Ebrill 2023 neu cyn hynny.

(2) Rhaid i gyd-bwyllgor corfforedig a sefydlir ar ôl 1 Ionawr 2022 gyhoeddi ei strategaeth tldi plant gyntaf heb fod yn hwyrach na 12 mis ar ôl y dyddiad y sefydlir y cyd-bwyllgor corfforedig.

(3) Rhaid i strategaethau dilynol gael eu cyhoeddi ar y dyddiad y mae cyfnod y strategaeth ar gyfer y strategaeth yn dechrau neu cyn hynny.

## Interpretation

### 2. In these Regulations—

- (a) “child poverty strategy” means a strategy setting out each of the things specified in section 2(1) of the Children and Families (Wales) Measure 2010;
- (b) “corporate joint committee” means a corporate joint committee established by regulations made under Part 5 of the Local Government and Elections (Wales) Act 2021;
- (c) “local authority” means a county council or county borough council in Wales;
- (d) “strategy period” means the period to which a child poverty strategy relates.

### **Strategy period for first and subsequent child poverty strategies**

3.—(1) The strategy period for the first child poverty strategy prepared by a corporate joint committee established on or before 1 January 2022 is the period beginning on 1 April 2023 and ending on 31 March 2026.

(2) The strategy period for the first child poverty strategy prepared by a corporate joint committee established after 1 January 2022 is the period—

- (a) beginning on the date the strategy is published (see regulation 4(2)), and
- (b) ending on 31 March in the third calendar year following the calendar year in which the strategy is published.

(3) The strategy period for subsequent child poverty strategies is the period of three years beginning on 1 April immediately following the end of strategy period for the previous strategy.

### **Timing of publication of the first and subsequent child poverty strategies**

4.—(1) A corporate joint committee established on or before 1 January 2022 must publish its first child poverty strategy on or before 1 April 2023.

(2) A corporate joint committee established after 1 January 2022 must publish its first child poverty strategy no later than 12 months after the date the corporate joint committee is established.

(3) Subsequent strategies must be published on or before the date on which the strategy period for the strategy begins.

## **Dull cyhoeddi strategaeth tlodi plant**

5.—(1) Rhaid i gyd-bwyllgor corfforedig gyhoeddi strategaeth tlodi plant drwy ei rhoi ar ei wefan ar y dyddiad y cyhoeddir y strategaeth a rhaid iddo gynnal y strategaeth ar y wefan honno drwy gydol cyfnod y strategaeth.

(2) Rhaid i gyd-bwyllgor corfforedig wneud trefniadau i anfon copi o unrhyw wybodaeth a gyhoeddir o dan baragraff (1) pan ofynnir amdano i unrhyw aelod o'r cyhoedd cyn gynted ag y bo'n rhesymol ymarferol ar ôl y gofynnir am gopi.

## **Adolygiad o'r strategaeth tlodi plant**

6.—(1) Rhaid i gyd-bwyllgor corfforedig adolygu pob un o'i strategaethau tlodi plant cyn diwedd cyfnod y strategaeth ar gyfer y strategaeth o dan sylw.

(2) Rhaid i gyd-bwyllgor corfforedig lunio adroddiad ar y cyfryw adolygiad a rhaid iddo gyhoeddi'r adroddiad adolygu drwy ei roi ar ei wefan.

(3) Rhaid i gyd-bwyllgor corfforedig wneud trefniadau i anfon copi o unrhyw wybodaeth a gyhoeddir o dan baragraff (2) pan ofynnir amdano i unrhyw aelod o'r cyhoedd cyn gynted ag y bo'n rhesymol ymarferol ar ôl y gofynnir am gopi.

## **Gofyniad ymgynghori**

7. Rhaid i gyd-bwyllgor corfforedig, cyn cyhoeddi strategaeth tlodi plant, ymgynghori â Gweinidogion Cymru, awdurdodau lleol a phersonau eraill sydd, yn nhyb y cyd-bwyllgor corfforedig, yn briodol.

## **Diwygio Rheoliadau'r Strategaeth Tlodi Plant (Cymru) 2011**

8. Yn rheoliad 2 o Reoliadau'r Strategaeth Tlodi Plant (Cymru) 2011(1), yn lle "nac awdurdod lleol" rhodder " , awdurdod lleol na chyd-bwyllgor corfforedig a sefydlir drwy reoliadau a wneir o dan Ran 5 o Ddeddf Llywodraeth Leol ac Etholiadau (Cymru) 2021".

## **Manner of publication of a child poverty strategy**

5.—(1) A corporate joint committee must publish a child poverty strategy by placing it on its website on the date that the strategy is published and maintaining the strategy on that website for the duration of the strategy period.

(2) A corporate joint committee must make arrangements to send a copy of any information published under paragraph (1) on request to any member of the public as soon as is reasonably practicable after a copy is requested.

## **Review of the child poverty strategy**

6.—(1) A corporate joint committee must review each of its child poverty strategies before the end of the strategy period for the strategy in question.

(2) A corporate joint committee must prepare a report of such a review and must publish the review report by placing it on its website.

(3) A corporate joint committee must make arrangements to send a copy of any information published under paragraph (2) on request to any member of the public as soon as is reasonably practicable after a copy is requested.

## **Consultation requirement**

7. Before publishing a child poverty strategy a corporate joint committee must consult the Welsh Ministers, local authorities and other persons it considers appropriate.

## **Amendment of the Child Poverty Strategy (Wales) Regulations 2011**

8. In regulation 2 of the Child Poverty Strategy (Wales) Regulations 2011(1), for "or a local authority" substitute " , a local authority or a corporate joint committee established by regulations made under Part 5 of the Local Government and Elections (Wales) Act 2021".
