Mae Atodlen 3 yn nodi'r cyrff a'r personau eraill sy'n awdurdodau rhestredig at ddibenion y Ddeddf honno ac sydd felly o fewn cylch gwaith Ombwdsmon Gwasanaethau Cyhoeddus Cymru ("yr Ombwdsmon").

Mae'r Rheoliadau hyn yn ychwanegu at Atodlen 3 gyd-bwyllgorau corfforedig a sefydlir drwy Reoliadau a wneir o dan Ran 5 o Ddeddf Llywodraeth Leol ac Etholiadau (Cymru) 2021 (dsc 1).

Mae adran 33 o Ddeddf Ombwdsmon Gwasanaethau Cyhoeddus (Cymru) 2019 yn ei gwneud yn ofynnol i Reoliadau o dan adran 31(2) sy'n ychwanegu person at Atodlen 3 bennu pa un a yw holl swyddogaethau'r person, ynteu dim ond rhai ohonynt, i ddod o fewn cylch gwaith yr Ombwdsmon o dan Ran 3 o'r Ddeddf honno (ymchwiliadau). Mae rheoliad 2(2) o'r Rheoliadau hyn yn pennu bod holl swyddogaethau cyd-bwyllgor corfforedig i ddod o fewn cylch gwaith yr Ombwdsmon o dan Ran 3 o'r Ddeddf honno.

Mae'r Rheoliadau hyn yn gysylltiedig â Rheoliadau sy'n sefydlu cyd-bwyllgorau corfforedig penodol o dan Ran 5 o Ddeddf Llywodraeth Leol ac Etholiadau (Cymru) 2021. Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Aseidiadau Effaith Rheoleiddiol

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend Schedule 3 to the Public Services Ombudsman (Wales) Act 2019 (anaw 3). Schedule 3 sets out the bodies and other persons who are listed authorities for the purposes of that Act and are therefore within the remit of the Public Services Ombudsman for Wales ("the Ombudsman").

These Regulations add to Schedule 3 corporate joint committees which are established by Regulations made under Part 5 of the Local Government and Elections (Wales) Act 2021 (asc 1).

Section 33 of the Public Services Ombudsman (Wales) Act 2019 requires that Regulations under section 31(2) which add a person to Schedule 3 must specify whether all or only some of that person's functions are to fall within the remit of the Ombudsman under Part 3 of that Act (investigations). Regulation 2(2) of these Regulations specifies that all of the functions of a corporate joint committee are to fall within the remit of the Ombudsman under Part 3 of that Act.

These Regulations are connected with Regulations which establish certain corporate joint committees under Part 5 of the Local Government and Elections (Wales) Act 2021. The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact

The Welsh Ministers have carried out consultation in accordance with section 31(4) of that Act.

Title and coming into force

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Deddf Ombwdsmon Gwasanaethau Cyhoeddus (Cymru) 2019 (Diwygio Atodlen 3) 2021.

1.—(1) The title of these Regulations is the Public Services Ombudsman (Wales) Act 2019 (Amendment of Schedule 3) Regulations 2021.

(2) These Regulations come into force on 1 April 2021.

2.—(1) Schedule 3 to the Public Services Ombudsman (Wales) Act 2019 (listed authorities) is amended as follows.

“Cyd-bwyllgor corfforedig a sefydlwyd drwy reoliadau a wnaed o dan Ran 5 o Ddeddf Llywodraeth Leol ac Etholiadau (Cymru) 2021.”

mewn perthynas â holl swyddogaethau cyd-bwyllgor corfforedig.

(2) Under the heading “Local government, fire and police”, at the end insert—

“A corporate joint committee established by regulations made under Part 5 of the Local Government and Elections (Wales) Act 2021.”

in relation to all of the functions of a corporate joint committee.
