Mae'r Gorchymyn hwn a wneir gan Weinidogion Cymru yn dwyn i rym ddarpariaethau penodol yn Neddf Iechyd a Gofal Cymdeithasol (Ansawdd ac Ymgysylltu) (Cymru) 2020 ("y Ddeddf").

Mae erthygl 2 o'r Gorchymyn hwn yn dwyn i rym baragraff 22 o Atodlen 1 i'r Ddeddf ar 1 Hydref 2022. Mae paragraff 22(1) yn ei gwneud yn ofynnol i Gorff Llais y Dinesydd ar gyfer Iechyd a Gofal Cymdeithasol, Cymru ("y Corff"), cyn dechrau pob blwyddyn ariannol, gyhoeddi cynllun sy'n nodi sut y mae'n bwriadu arfer ei swyddogaethau yn ystod y flwyddyn. Bydd y cynllun cyntaf o'r fath yn cael ei lunio gan y Corff fel rhan o'i waith paratoi cyn arfer ei swyddogaethau o sylwedd a fydd yn cael eu cychwyn drwy orchymyn cychwyn dilynol. Mae paragraff 22(2) yn darparu bod rhaid i'r cynllun gynnwys datganiad o amcanion a blaenoriaethau'r Corff am y flwyddyn. Mae paragraff 22(3) yn ei gwneud yn ofynnol bod rhaid i'r Corff, cyn cyhoeddi cynllun, ymgynghori ag unrhyw bersonau y mae'n ystyried eu bod yn briodol ynghylch ei amcanion a blaenoriaethau arfaethedig.

**EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order made by the Welsh Ministers brings into force certain provisions of the Health and Social Care (Quality and Engagement) (Wales) Act 2020 ("the Act").

Article 2 of this Order brings into force paragraph 22 of Schedule 1 to the Act on 1 October 2022. Paragraph 22(1) requires the Citizen Voice Body for Health and Social Care, Wales ("the Body"), before the start of each financial year, to publish a plan setting out how it proposes to exercise its functions during the year. The first such plan will be prepared by the Body as part of its preparatory work in advance of the exercise of its substantive functions that will be commenced by way of a subsequent commencement order. Paragraph 22(2) provides that the plan must include a statement of the Body's objectives and priorities for the year. Paragraph 22(3) requires that, before publishing a plan, the Body must consult such persons as it considers appropriate on its proposed objectives and priorities.

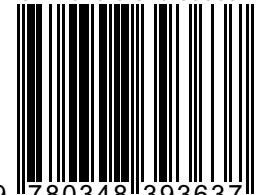
