Mae'r Rheoliadau hyn yn diwygio Rheoliadau'r Gwasanaeth Iechyd Gwladol (Ffioedd a Thaliadau Optegol) 1997 ("y Rheoliadau Optegol") sy'n darparu i daliadau gael eu gwneud drwy system dalebau o ran y costau yr eir iddynt gan gategorïau penodol o bersonau mewn cysylltiad â phroffion golwg a chyflenwi, amnewid a thrwsio teclynnau optegol.

Mae rheoliad 2 yn diwygio rheoliad 1(2) o'r Rheoliadau Optegol i ddiweddarwr cyfeiriad yn y diffiniad o "small glasses" at y ddogfen Safonau Prydeinig berthnasol, i ddiwygio'r diffiniad o "face value" er mwyn cyfeirio at godau rhif talebau, yn hytrach na chodau llythyren, i ddiwygio'r diffiniad o "NHS sight test fee", ac i fewnosod diffiniad o "prisoner". Mae rheoliad 2 hefyd yn diwygio rheoliad 1(2) a (3) o'r Rheoliadau Optegol i roi cyfeiriadau at "multifocal lenses", sy'n cynnwys lensys deuffocal a lensys amrywffocal fel ei gilydd, yn lle cyfeiriadau at "bifocal lenses".

Mae rheoliad 3 yn diwygio rheoliad 8 o'r Rheoliadau Optegol i wneud carcharorion ar absenoldeb awdurdodedig yn gymwys i gael taleb ar gyfer cyflenwi teclyn optegol.

Mae rheoliadau 4, 5, 7 ac 8 yn gwneud diwygiadau i'r Rheoliadau Optegol i adlewyrchu'r newid o godau llythyren talebau i godau rhif talebau yn Atodlen 1 i'r Rheoliadau hynny.

EXPLANATORY NOTE

(*This note is not part of the Regulations*)

These Regulations amend the National Health Service (Optical Charges and Payments) Regulations 1997 ("the Optical Regulations") which provide for payments to be made by means of a voucher system in respect of costs incurred by certain categories of persons in connection with sight tests and the supply, replacement and repair of optical appliances.

Regulation 2 amends regulation 1(2) of the Optical Regulations to update the reference in the definition of "small glasses" to the relevant British Standards document, to amend the definition of "face value" to refer to voucher number codes, rather than letter codes, to amend the definition of "NHS sight test fee", and to insert a definition of "prisoner". Regulation 2 also amends regulation 1(2) and (3) of the Optical Regulations to replace references to "bifocal lenses" with "multifocal lenses", which include both bifocal and varifocal lenses.

Regulation 3 amends regulation 8 of the Optical Regulations to make prisoners on leave eligible for a voucher for the supply of an optical appliance.

Regulations 4, 5, 7 and 8 make amendments to the Optical Regulations to reflect the change from voucher letter codes to voucher number codes in Schedule 1 to those Regulations.

Mae rheoliad 6 yn diwygio rheoliad 15 o'r Rheoliadau Optegol. Yn gyntaf, i ddarparu bod carcharorion ar absenoldeb awdurdodedig yn gymwys i gael taleb ar gyfer trwsio ac amnewid teclyn optegol o dan amgylchiadau penodedig. Yn ail, i ddarparu bod categoriâu penodol o berson yn gymwys i gael taleb ar gyfer trwsio ac amnewid ni waeth pa un a yw eu teclyn optegol wedi ei golli neu ei ddifrodi o ganlyniad i salwch.

Mae rheoliad 9 a'r Atodlenni yn diwygio Atodlenni 1, 2 a 3 i'r Rheoliadau Optegol i newid gwerth talebau a ddyroddir tuag at y gost o gyflenwi, amnewid a thrwsio teclynnau optegol ac i ddarparu ar gyfer cynyddu gwerth talebau a ddyroddir i bobl gymwys o dan 19 oed o dan amgylchiadau penodol.

Mae rheoliad 10 yn gwneud darpariaeth drosiannol mewn perthynas â thalebau a ddyroddir neu a gwblheir ond sydd heb eu defnyddio na'u derbyn cyn 20 Hydref 2023.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, lluniwyd asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn. Gellir cael copi oddi wrth: Yr Is-adran Gofal Sylfaenol ac Iechyd Meddwl, Llywodraeth Cymru, Parc Cathays, Caerdydd CF10 3NQ.

Regulation 6 amends regulation 15 of the Optical Regulations. Firstly, to provide that prisoners on leave are eligible for a voucher for repair and replacement of an optical appliance in specified circumstances. Secondly, to provide that certain categories of person are eligible for a voucher for repair and replacement regardless of whether their optical appliance has been lost or damaged as a consequence of illness.

Regulation 9 and the Schedules amend Schedules 1, 2 and 3 to the Optical Regulations to change the value of vouchers issued towards the cost of the supply, replacement and repair of optical appliances and to provide for an uplift to the value of vouchers issued to eligible people under 19 years old in certain circumstances.

Regulation 10 makes transitional provision in relation to vouchers issued or completed but not used or accepted before 20 October 2023.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, a regulatory impact assessment has been prepared as to the likely costs and benefits of complying with these Regulations. The Welsh Ministers make these Regulations in exercise of the powers conferred by sections 71, 129 and 203(9) and (10) of the National Health Service (Wales) Act 2006(1).

Title, coming into force and interpretation

1.—(1) The title of these Regulations is the National Health Service (Optical Charges and Payments) (Amendment) (Wales) Regulations 2023 and they come into force on 20 October 2023.

(2) In these Regulations, "the Optical Regulations" means the National Health Service (Optical Charges and Payments) Regulations 1997(2).

Amendments to regulation 1 of the Optical Regulations

2.—(1) Regulation 1 (citation, commencement and interpretation) is amended as follows.

(2) In paragraph (2)—

- (a) in the definition of "complex appliance", for "bifocal" substitute "multifocal";

(1) 2006 c. 42; *see* section 206(1) for the meaning of "prescribed" and "regulations". There are amendments to section 203 which are not relevant to these Regulations.

(2) S.I. 1997/818 as amended by S.I. 2016/305 (W. 101), S.I. 2016/1059 (W. 250) and S.I. 2021/916 (W. 209). There are other amending instruments which are not relevant to these Regulations.

- (b) yn y diffiniad o “face value”, yn lle “letter” rhodder “number”;
- (c) yn lle’r diffiniad o “NHS sight test fee” rhodder—

““NHS sight test fee” means the fee for a sight test determined by the Welsh Ministers under section 76 of the National Health Service (Wales) Act 2006(1) (remuneration for persons providing general ophthalmic services);”;

““prisoner” means a person who is detained in a prison, including a young offender institution, a secure training centre, and a naval, military or air force prison, but is, at the time of receiving any sight test under section 71 of the National Health Service (Wales) Act 2006(3) (arrangements for general ophthalmic services), on leave from that prison, and for the purposes of this definition—

- (a) “secure training centre” means a place in which offenders subject to detention and training orders within the meaning given by section 233 of the Sentencing Code(4) may be detained and given training and education and prepared for their release, and
- (b) “young offender institution” means a place for the detention of offenders sentenced to detention in a young offender institution or to custody for life;”.

(3) Ym mharagraff (3), yn lle “bifocal” rhodder “multifocal” ym mhob lle y mae’n digwydd.

- (b) in the definition of “face value”, for “letter” substitute “number”;

- (c) for the definition of “NHS sight test fee” substitute—

““NHS sight test fee” means the fee for a sight test determined by the Welsh Ministers under section 76 of the National Health Service (Wales) Act 2006(1) (remuneration for persons providing general ophthalmic services);”;

- (d) in the definition of “small glasses”, for “British Standard BS EN ISO 8624:2011 (Ophthalmic Optics. Spectacle Frames. Measuring System and Terminology) published on 28 February 2011” substitute “British Standard BS EN ISO 8624:2020 (Ophthalmic Optics. Spectacle Frames. Measuring System and Vocabulary) published on 31 July 2020(2)”;
- (e) at the appropriate place in the alphabetical order insert—

““prisoner” means a person who is detained in a prison, including a young offender institution, a secure training centre, and a naval, military or air force prison, but is, at the time of receiving any sight test under section 71 of the National Health Service (Wales) Act 2006(3) (arrangements for general ophthalmic services), on leave from that prison, and for the purposes of this definition—

- (a) “secure training centre” means a place in which offenders subject to detention and training orders within the meaning given by section 233 of the Sentencing Code(4) may be detained and given training and education and prepared for their release, and
- (b) “young offender institution” means a place for the detention of offenders sentenced to detention in a young offender institution or to custody for life;”.

(3) In paragraph (3), for “bifocal” substitute “multifocal” on each occasion it occurs.

(3) Ym mharagraff (1)(b) yn lle “(c), (d) or (e)” rhodder “(d), (e) or (f), or regulation 8(2)(c) and regulation 8(3)(a), (b), (e), (f), (i), (j), (l), (o), (p) or (q)”.

6.—(1) Regulation 15 (eligibility – replacement or repair) is amended as follows.

(2) In paragraph (1)(a), after “child” insert “or a person of the description specified in regulation 8(2)(c) and regulation 8(3)(k) or (ka)”.

(3) In paragraph (1)(b) for “(c), (d) or (e)” substitute “(d), (e) or (f), or regulation 8(2)(c) and regulation 8(3)(a), (b), (e), (f), (i), (j), (l), (o), (p) or (q)”.

Amendment to regulation 16 of the Optical Regulations

7.—(1) Regulation 16 (completion of vouchers) is amended as follows—

(2) In paragraph 2(b), for “letter” substitute “number”.

(3) In paragraph 3(b), for “letter” substitute “number”.

Amendment to regulation 19 of the Optical Regulations

8. In paragraph 2(b) of regulation 19 (redemption value of voucher for replacement or repair), for “letter” substitute “number”.

“(1A) In addition to any increase under sub-paragraph (1), the amount in column 3 of Schedule 1 relating to a voucher with the number code 1 must be increased by £15.00 where—

- (a) that voucher is issued to an eligible person who is under the age of 19 years,
- (b) the eligible person has been issued a prescription for single vision lenses of a spherical power of between 4 and 6 dioptres, with a cylindrical power of not more than 2 dioptres, and
- (c) the ophthalmic medical practitioner or optician that issues the voucher considers a non-stock lens supplement is required to improve the cosmetic appearance of the optical appliance in relation to which the voucher will be used.

(1B) For the purposes of sub-paragraph (1A), “non-stock lens supplement” means surfacing of the lenses or using high index or aspheric lenses.”

(4) Yn lle Atodlen 3 (gwerthoedd talebau – trwsio) rhodder yr Atodlen 3 a geir yn Atodlen 2 i'r Rheoliadau hyn.

Amendments to the Schedules to the Optical Regulations

9.—(1) Schedules 1 to 3 to the Optical Regulations are amended as follows.

(2) For Schedule 1 (voucher letter codes and face values – supply and replacement) substitute the Schedule 1 contained in Schedule 1 to these Regulations.

(3) In Schedule 2 (prisms, tints, photochromic lenses, small and special glasses and complex appliances)—

- (a) in paragraph 1(1)(a), for “£12.60” substitute “£12.00”;
- (b) in paragraph 1(1)(b), for “£15.40” substitute “£14.00”;
- (c) in paragraph 1(1)(c), for “£4.40” substitute “£2.00”;
- (d) in paragraph 1(1)(d), for “£4.90” substitute “£2.50”;
- (e) after sub-paragraph 1(1), insert—

“(1A) In addition to any increase under sub-paragraph (1), the amount in column 3 of Schedule 1 relating to a voucher with the number code 1 must be increased by £15.00 where—

- (a) that voucher is issued to an eligible person who is under the age of 19 years,
- (b) the eligible person has been issued a prescription for single vision lenses of a spherical power of between 4 and 6 dioptres, with a cylindrical power of not more than 2 dioptres, and
- (c) the ophthalmic medical practitioner or optician that issues the voucher considers a non-stock lens supplement is required to improve the cosmetic appearance of the optical appliance in relation to which the voucher will be used.

(1B) For the purposes of sub-paragraph (1A), “non-stock lens supplement” means surfacing of the lenses or using high index or aspheric lenses.”

(4) For Schedule 3 (voucher values – repair) substitute the Schedule 3 contained in Schedule 2 to these Regulations.

Darpariaeth drosiannol

10.—(1) Nid yw'r symiau a amnewidir gan reoliad 9 yn gymwys ond mewn perthynas â thaleb a ddyroddir yn unol â rheoliad 9, 10 neu 11 neu a gwblheir yn unol â rheoliad 16 o'r Rheoliadau Optegol ar neu ar ôl 20 Hydref 2023.

(2) O ran taleb—

- (a) pan fo wedi ei dyroddi yn unol â rheoliad 9, 10 neu 11 neu wedi ei chwblhau yn unol â rheoliad 16 o'r Rheoliadau Optegol, ond
- (b) pan na fo wedi ei defnyddio na'i derbyn yn unol â rheoliad 12 na 17 o'r Rheoliadau Optegol ar yr adeg y daw'r Rheoliadau hyn i rym,

mae i'r daleb honno yr wynebwerth y darperir ar ei gyfer yn y Rheoliadau Optegol fel yr oeddent yn bodoli yn union cyn i'r Rheoliadau hyn ddod i rym ac mae gwerth adbrynu'r daleb i gael ei gyfrifo yn unol â hynny.

Transitional provision

10.—(1) The amounts substituted by regulation 9 apply only in relation to a voucher issued pursuant to regulation 9, 10 or 11 or completed pursuant to regulation 16 of the Optical Regulations on or after 20 October 2023.

(2) Where a voucher—

- (a) has been issued pursuant to regulation 9, 10 or 11 or completed pursuant to regulation 16 of the Optical Regulations, but
- (b) has not been used or accepted pursuant to regulation 12 or 17 of the Optical Regulations at the coming into force of these Regulations,

that voucher has the face value provided for in the Optical Regulations as they existed immediately before these Regulations come into force and the voucher's redemption value is to be calculated accordingly.
