# ROAD TRAFFIC, WALES

The A458 Trunk Road (East of Buttington Cross, Buttington, Powys) (Temporary Traffic Prohibitions) Order 2024

Made 19 February 2024

Coming into force 27 February 2024

The Welsh Ministers, as traffic authority for the A458 trunk road, are satisfied that traffic on a specified length of the trunk road should be prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

## Title and commencement

**1.** The title of this Order is the A458 Trunk Road (East of Buttington Cross, Buttington, Powys) (Temporary Traffic Prohibitions) Order 2024 and this Order comes into force on 27 February 2024.

## Interpretation

# 2. In this Order—

"exempted vehicle" ("cerbyd esempt") means any vehicle being used by the emergency services or in connection with the works giving rise to this Order:

"the trunk road" ("y gefnffordd") means the A458 Shrewsbury to Dolgellau trunk road that extends

from the eastern junction of Buttington Cross Roundabout in an easterly direction for a distance of 250 metres to a point adjacent to the dwelling known as Cambrian Cottage at Buttington in the County of Powys;

"works period" ("cyfnod y gwaith") means the period commencing at 22:00 hours on 27 February 2024 and ending when the temporary traffic signs are permanently removed.

#### **Prohibitions**

- **3.** No person may, during the works period, drive any vehicle, other than an exempted vehicle, on the length of the trunk road.
- **4.** No person may, during the works period, ride any pedal cycle on the length of the trunk road.
- **5.** No pedestrian may, during the works period, proceed on the length of the trunk road.

# **Application**

**6.** The prohibitions in articles 3, 4 and 5 apply only during such times and to such extent as indicated by traffic signs.

### **Duration of this Order**

7. The maximum duration of this Order is 6 months.
