Mae Rhan 1 o'r Rheoliadau hyn yn gwneud darpariaeth ynghylch dod â'r Rheoliadau hyn i rym a'u cymhwyso.

Mae Pennod 2 yn Rhan 2, Rhan 3 a Rhan 4 yn diwygio symiau amrywiol a bennir yn Rheoliadau 2017, Rheoliadau 2018 a'r Rheoliadau Benthyciadau at Radd Ddoethurol yn y drefn honno.

Mae Pennod 3 yn Rhan 2 a Rhan 3 yn diwygio Rheoliadau 2017 a Rheoliadau 2018 yn y drefn honno i gynyddu swm yr incwm a ddiystyrir wrth gyfrifo swm y grantiau ar gyfer dibynyddion.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Aseidiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal aseiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

**EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations amend—

- the Education (Student Support) (Wales) Regulations 2017 (“the 2017 Regulations”) (see Part 2 of the Regulations),
- the Education (Student Support) (Wales) Regulations 2018 (“the 2018 Regulations”) (see Part 3 of the Regulations), and
- the Education (Postgraduate Doctoral Degree Loans) (Wales) Regulations 2018 (“the Doctoral Degree Loan Regulations”) (see Part 4 of the Regulations).

Part 1 of these Regulations provides for the coming into force and application of these Regulations.

Chapter 2 in Part 2, Part 3 and Part 4 amends various amounts specified in the 2017 Regulations, the 2018 Regulations and the Doctoral Degree Loan Regulations respectively.

Chapter 3 in Part 2 and Part 3 amends the 2017 Regulations and the 2018 Regulations respectively to increase the amount of income disregarded when calculating the amount of grants for dependants.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

Mae Gweinidogion Cymru yn gwneud y Rheoliadau a ganlyn drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adrannau 22(1)(a), 22(2)(b) ac (c) a 42(6) o Ddeddf Addysgu ac Addysg Uwch 1998(1), ac sydd bellach yn arferadwy ganddynt hwy(2).

The Welsh Ministers make the following Regulations in exercise of the powers conferred upon the Secretary of State by sections 22(1)(a), 22(2)(b) and (c) and 42(6) of the Teaching and Higher Education Act 1998(1), and now exercisable by them(2).

Trosglwyddwyd swyddogaethau Cynulliad Cenedlaethol Cymru i Weinidogion Cymru yn rhinwedd adran 162 o Ddeddf Llywodraeth Cymru 2006 (p. 32) a pharagraff 30 o Atodlen 11 iddi.

(2) The functions of the Secretary of State in sections 22(1)(a) and 22(2)(b) of the Teaching and Higher Education Act 1998 were transferred to the National Assembly for Wales, so far as they relate to making provision in relation to Wales, by section 44 of the Higher Education Act 2004 (c. 8). Section 44 of that Act also provided that the function in section 22(2)(c) of the Teaching and Higher Education Act 1998 was to be exercised by the National Assembly for Wales concurrently with the Secretary of State, so far as it relates to making provision in relation to Wales. The Secretary of State's function in section 42(6) of the Teaching and Higher Education Act 1998, in so far as being exercisable in relation to Wales, was transferred to the National Assembly for Wales by the National Assembly for Wales (Transfer of Functions) Order 1999, article 2 and Schedule 1 (S.I. 1999/672). The functions of the National Assembly for Wales were transferred to the Welsh Ministers by virtue of section 162 of, and paragraph 30 of Schedule 11 to, the Government of Wales Act 2006 (c. 32).

## PART 1

Title, coming into force and application

### Title and coming into force

1.—(1) The title of these Regulations is the Education (Student Finance) (Amounts) (Miscellaneous Amendments) (Wales) Regulations 2024.

(2) These Regulations come into force on 22 February 2024.

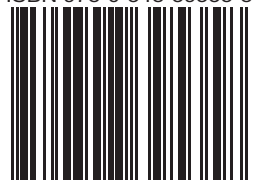
