



# Administrative and Financial Provisions Act (Northern Ireland) 1956

## 1956 CHAPTER 17

An Act to make certain amendments in the law relating to holdings subject to land purchase annuity; to amend the law with respect to the duration and cost of firearm certificates and permits; to make further provision with respect to the salary of the Comptroller and Auditor-General; to make further provision with respect to public accounts and the receipt, issue, borrowing and funding of public moneys; to provide for the variation of the rate of interest payable on certain compensation moneys; and otherwise to amend the law with respect to certain administrative and financial matters and with respect to certain functions of the Ministry of Finance. ### 1<sup>F1</sup> **Amendment of certain provisions of the Land Purchase Acts as to the creation of certain tenancies.**

Notwithstanding anything contained in the following enactments—

it shall not be necessary to obtain the consent of the Ministry of Finance to the creation of any tenancy for a term of thirty-one years or less of a holding or part of a holding to which those enactments apply and, accordingly, those enactments shall not apply to any such tenancy created after the passing of this Act.
