### **GENERAL**

### 212 Application to the Londonderry Area.

- (1) Without prejudice to any other provision of this Act the following provisions shall not (except in so far as any of them have effect with respect to sea-fisheries) apply to the Londonderry Area[F1] or the Newry Area], that is to say,
  - sections [ $^{F2}$ 14] to 16, Parts II and III [ $^{F3}$  (except section 45),] sections 46 to 50, 62 to 73 and 78 to 88, Part VI, and sections 110, 111, 120(5), 160, 161, 170[ $^{F4}$ , 170A and 171] to 174,[ $^{F4}$  175(2),] [ $^{F5}$  176 to[ $^{F4}$  179 and 180 to] 181 and 197].

    - (b) approving, under section 6, any programme relating to such waters.
