

Mental Health (Care and Treatment) (Scotland) Act 2003



The Bill for this Act of the Scottish Parliament was passed by the Parliament on 20th March 2003 and received Royal Assent on 25th April 2003

An Act of the Scottish Parliament to restate and amend the law relating to mentally disordered persons; and for connected purposes.

INTRODUCTORY

1 Principles for discharging certain functions S

- (1) Subsections (2) to (4) below apply whenever a person who does not fall within subsection (7) below is discharging a function by virtue of this Act in relation to a patient who has attained the age of 18 years.
- (2) In discharging the function the person shall, subject to subsection (9) below, have regard to the matters mentioned in subsection (3) below in so far as they are relevant to the function being discharged.
- (3) The matters referred to in subsection (2) above are—
 - (a) the present and past wishes and feelings of the patient which are relevant to the discharge of the function;

- (b) the views of—
 - (i) the patient's named person;
 - (ii) any carer of the patient;
 - (iii) any guardian of the patient; and
 - (iv) any welfare attorney of the patient,

which are relevant to the discharge of the function;

- (c) the importance of the patient participating as fully as possible in the discharge of the function;
- (d) the importance of providing such information and support to the patient as is necessary to enable the patient to participate in accordance with paragraph (c) above;
- (e) the range of options available in the patient's case;
- (f) the importance of providing the maximum benefit to the patient;
- (g) the need to ensure that, unless it can be shown that it is justified in the circumstances, the patient is not treated in a way that is less favourable than the way in which a person who is not a patient might be treated in a comparable situation:
- (h) the patient's abilities, background and characteristics, including, without prejudice to that generality, the patient's age, sex, sexual orientation, religious persuasion, racial origin, cultural and linguistic background and membership of any ethnic group.
- (4) After having regard to—
 - (a) the matters mentioned in subsection (3) above;
 - (b) if subsections (5) and (6) below apply, the matters mentioned there; and
 - (c) such other matters as are relevant in the circumstances,

the person shall discharge the function in the manner that appears to the person to be the manner that involves the minimum restriction on the freedom of the patient that is necessary in the circumstances.

- (5) Whenever a person who does not fall within subsection (7) below is discharging a function by virtue of this Act (other than the making of a decision about medical treatment) in relation to a patient, the person shall have regard, in so far as it is reasonable and practicable to do so, to—
 - (a) the needs and circumstances of any carer of the patient which are relevant to the discharge of the function and of which the person is aware; and
 - (b) the importance of providing such information to any carer of the patient as might assist the carer to care for the patient.
- (6) Whenever a person who does not fall within subsection (7) below is discharging a function by virtue of this Act in relation to a person who is, or has been, subject to—
 - (a) detention in hospital authorised by a certificate granted under section 36(1) of this Act (any such certificate being referred to in this Act as an "emergency detention certificate");
 - (b) detention in hospital authorised by a certificate granted under section 44(1) of this Act (any such certificate being referred to in this Act as a "short-term detention certificate");
 - (c) an order made under section 64(4)(a) of this Act (any such order being referred to in this Act as a "compulsory treatment order"); or

(d) an order made under section 57A(2) of the 1995 Act (any such order being referred to in this Act as a "compulsion order"),

the person who is discharging the function shall have regard to the importance of the provision of appropriate services to the person who is, or has been, subject to the certificate or order concerned (including, without prejudice to that generality, the provision of continuing care when the person is no longer subject to the certificate or order).

- (7) A person falls within this subsection if the person is discharging the function by virtue of being—
 - (a) the patient;
 - (b) the patient's named person;
 - (c) the patient's primary carer;
 - (d) a person providing independent advocacy services to the patient under section 259 of this Act;
 - (e) the patient's legal representative;
 - (f) a curator ad litem appointed by the Tribunal in respect of the patient;
 - (g) a guardian of the patient; or
 - (h) a welfare attorney of the patient.
- (8) In subsection (3)(a) above, the reference to wishes and feelings of the patient is a reference to those wishes and feelings in so far as they can be ascertained by any means of communication, whether human or by mechanical aid (whether of an interpretative nature or otherwise), appropriate to the patient.
- (9) The person need not have regard to the views of a person mentioned in subsection (3) (b) above in so far as it is unreasonable or impracticable to do so.
- (10) In subsection (3)(d) above, the reference to information is to information in the form that is mostly likely to be understood by the patient.
- (11) In this section, a reference to "discharging", in relation to a power, includes a reference to exercising the power by taking no action; and "discharge" shall be construed accordingly.

Welfare of the child S

- (1) This section applies whenever a person who does not fall within section 1(7) of this Act is discharging a function, by virtue of this Act, to which subsection (2) or (3) below applies in relation to a patient who is under the age of 18 years.
- (2) This subsection applies to any duty which may be discharged in more than one manner.
- (3) This subsection applies to any power.
- (4) The person shall discharge the function in the manner that appears to the person to be the manner that best secures the welfare of the patient.

- (5) In determining the manner of discharging the function that best secures the welfare of the patient, the person shall have regard to—
 - (a) the matters mentioned in section 1(3) of this Act:
 - (b) the matters mentioned in section 1(5) and (6) of this Act (where those subsections apply); and
 - (c) the importance of the function being discharged in the manner that appears to the person to be the manner that involves the minimum restriction on the freedom of the patient that is necessary in the circumstances.
- (6) Subsections (8) to (10) of section 1 of this Act shall apply for the purpose of subsection (5)(a) above as they apply in relation to subsection (3) of that section.
- (7) In this section, a reference to "discharging", in relation to a power, includes a reference to exercising the power by taking no action; and "discharge" shall be construed accordingly.

3 Equal opportunities S

- (2) The person shall discharge the function in a manner that encourages equal opportunities and in particular the observance of the equal opportunity requirements.
- (3) The persons referred to in subsection (1) above are—
 - (a) the Scottish Ministers;
 - (b) the Commission;
 - (c) a local authority;
 - (d) a Health Board;
 - (e) a Special Health Board;
 - (f) a National Health Service trust;
 - [F1(fa) (as respects its health service functions only) Healthcare Improvement Scotland;]
 - (g) the managers of a hospital;
 - (h) a mental health officer;
 - (i) a patient's responsible medical officer;
 - (i) a medical practitioner; and
 - (k) a nurse

4 The Mental Welfare Commission for Scotland S

- (1) There shall continue to be a body corporate known as the Mental Welfare Commission for Scotland (in this Act referred to as "the Commission").
- (2) The Commission shall discharge such functions as are conferred on it by virtue of—
 - (a) this Act;
 - (b) the Adults with Incapacity (Scotland) Act 2000 (asp 4); and
 - (c) any other enactment.
- [F2(2A) In so discharging its functions, the Commission shall act in a manner which seeks to protect the welfare of persons who have a mental disorder.]
 - (3) Schedule 1 to this Act (which makes provision as respects the Commission) shall have effect.

4ZB General functions of NCF S

The general functions of NCF are—

- (a) to provide means for persons who were placed in institutional care as children to describe in confidence (such descriptions being referred to in this Act as "testimony")—
 - (i) experiences of that care,
 - (ii) any abuse experienced during the period spent in that care,
- (b) to acknowledge testimony by enabling it to be given at hearings established by NCF or by written or other means,
- (c) based on testimony received—
 - (i) to identify any patterns and trends in the experiences of persons placed in institutional care as children (including the causes, nature, scale and circumstances of any abuse experienced), and
 - (ii) to make recommendations about policy and practice which NCF considers will improve institutional care (including by protecting children from, and preventing or reducing the incidence of, abuse),
- (d) while preserving the anonymity of participants, establishments providing institutional care and other persons, to prepare reports of the testimony it receives and its recommendations in relation to them,
- (e) to provide information about advice and assistance available to persons giving, or proposing to give, testimony.

8 Duty to bring specific matters to attention of Scottish Ministers and others etc. S

- (1) If it appears to the Commission that a relevant person has, or may have, powers or duties, the exercise or performance of which might prevent or remedy or assist in preventing or remedying, as respects a person who has a mental disorder, any of the circumstances mentioned in subsection (2) below, the Commission shall—
 - (a) bring the facts of the person's case to the attention of the relevant person; and
 - (b) if it considers it appropriate to do so, make recommendations as respects the case to the relevant person.
- (2) Those circumstances are—
 - (a) the circumstances mentioned in section 11(2)(a), (d), (e) or (f) of this Act;
 - (b) that—
 - (i) the patient is detained in hospital and the detention is authorised by virtue of this Act or the 1995 Act; and
 - (ii) there may be some impropriety in relation to that detention.
- (3) For the purposes of subsection (1) above, "relevant person" means—
 - (a) the Scottish Ministers;
 - (b) the Public Guardian;
 - (c) a local authority;
 - (d) a Health Board;
 - (e) a Special Health Board;
 - (f) a National Health Service trust;
 - (g) a mental health officer;
 - (h) a responsible medical officer;
 - (i) the managers of a registered care service;

- (1) The Commission shall, as it considers appropriate, raise any concerns (of a general or specific nature) about the provision of any service mentioned in subsection (2) as respects a person who has a mental disorder, with—

Emergency detention certificate

36 Emergency detention in hospital S

- (1) Where—
 - (a) a medical practitioner carries out a medical examination of a patient;
 - (b) the patient does not fall within subsection (2) below; and
 - (c) subsection (3) below applies,

the medical practitioner may, before the expiry of the appropriate period, grant an emergency detention certificate authorising, if the condition mentioned in subsection (7) below is satisfied, the measures mentioned in subsection (8) below.

- (2) The patient falls within this subsection if, immediately before the medical examination mentioned in subsection (1)(a) above is carried out, the patient is I^{F59}subject tol—
 - (a) an emergency detention certificate;
 - (b) a short-term detention certificate;
 - (c) an extension certificate;
 - (d) section 68 of this Act; or
 - (e) a certificate granted under section 114(2) or 115(2) of this Act.
- (3) Subject to subsection (6) below, this subsection applies where—
 - (a) there is no conflict of interest in relation to the medical examination;
 - (b) the medical practitioner considers that it is likely that the conditions mentioned in subsection (4) below are met in respect of the patient;
 - (c) the medical practitioner is satisfied that the conditions mentioned in subsection (5) below are met in respect of the patient; and
 - (d) the medical practitioner has consulted a mental health officer and that mental health officer has consented to the grant of an emergency detention certificate.

- (7) The condition referred to in subsection (1) above is that the measure mentioned in subsection (8)(b)(i) below is authorised by the certificate only if, before the patient is admitted under authority of the certificate to a hospital, the certificate is given to the managers of that hospital.
- (8) The measures referred to in subsection (1) above are—
 - (a) the removal, before the expiry of the period of 72 hours beginning with the granting of the emergency detention certificate, of the patient to a hospital or to a different hospital; and
 - (b) the detention of the patient in hospital for the period of 72 hours beginning with—
 - (i) if, immediately before the certificate is granted, the patient is not in hospital, the first admission under authority of the certificate of the patient to hospital;

"Compulsion orders

57A Compulsion order

- (1) This section applies where a person (in this section and in sections [F8257B to] 57D of this Act, referred to as the "offender")—
 - (a) is convicted in the High Court or the sheriff court of an offence punishable by imprisonment (other than an offence the sentence for which is fixed by law); or
 - (b) is remitted to the High Court by the sheriff under any enactment for sentence for such an offence.
- (2) If the court is satisfied—
 - (a) on the written or oral evidence of two medical practitioners, that the conditions mentioned in subsection (3) below are met in respect of the offender; and
 - (b) that, having regard to the matters mentioned in subsection (4) below, it is appropriate,

it may, subject to subsection (5) below, make an order (in this Act referred to as a "compulsion order") authorising, subject to subsection (7) below, for the period of 6 months beginning with the day on which the order is made such of the measures mentioned in subsection (8) below as may be specified in the order.

- (3) The conditions referred to in subsection (2)(a) above are—
 - (a) that the offender has a mental disorder;
 - (b) that medical treatment which would be likely to—
 - (i) prevent the mental disorder worsening; or
 - (ii) alleviate any of the symptoms, or effects, of the disorder,

is available for the offender;

- (c) that if the offender were not provided with such medical treatment there would be a significant risk—
 - (i) to the health, safety or welfare of the offender; or
 - (ii) to the safety of any other person; and
- (d) that the making of a compulsion order in respect of the offender is necessary.
- (4) The matters referred to in subsection (2)(b) above are—
 - (a) the mental health officer's report, prepared in accordance with section 57C of this Act, in respect of the offender;

 - (i) the nature of the offence of which the offender was convicted;
 - (ii) the antecedents of the offender; and
 - (c) any alternative means of dealing with the offender.

 - (b) that such conditions of special security can be provided only in a state hospital.
- (7) Where the court—
 - (a) makes a compulsion order in respect of an offender; and
 - (b) also makes a restriction order in respect of the offender,

the compulsion order shall authorise the measures specified in it without limitation of time.

- (8) The measures mentioned in subsection (2) above are—
 - (a) the detention of the offender in the specified hospital;
 - (b) the giving to the offender, in accordance with Part 16 of the Mental Health (Care and Treatment) (Scotland) Act 2003 (asp 13), of medical treatment:
 - (c) the imposition of a requirement on the offender to attend—
 - (i) on specified or directed dates; or
 - (ii) at specified or directed intervals,

specified or directed places with a view to receiving medical treatment;

 - (i) on specified or directed dates; or
 - (ii) at specified or directed intervals,

specified or directed places with a view to receiving community care services, relevant services or any treatment, care or service;

- (f) the imposition of a requirement on the offender to allow—
 - (i) the mental health officer;
 - (ii) the offender's responsible medical officer; or
 - (iii) any person responsible for providing medical treatment, community care services, relevant services or any treatment, care or service to the offender who is authorised for the purposes of this paragraph by the offender's responsible medical officer,

to visit the offender in the place where the offender resides;

- (11) The power conferred by subsection (10) above may be exercised so as to make different provision for different cases or descriptions of case or for different purposes.
- (12) No regulations shall be made under subsection (10) above unless a draft of the statutory instrument containing them has been laid before, and approved by a resolution of, the Scottish Parliament.

 - (vi) make a probation order; or

57D Compulsion order: supplementary

CHAPTER 3 S

MENTALLY DISORDERED PRISONERS

136 Transfer of prisoners for treatment for mental disorder S

- (1) This section applies where a person (in this section referred to as the "prisoner") is serving a sentence of imprisonment.

 - (i) a constable;
 - (ii) a person employed in, or contracted to provide services in or to, the specified hospital who is authorised by the managers of that hospital to remove persons to hospital for the purposes of this section; or
 - (iii) a specified person;
 - (b) the detention of the prisoner in the specified hospital; and
 - (c) the giving to the prisoner, in accordance with Part 16 of this Act, of medical treatment.
- (7) The Scottish Ministers shall be satisfied as to the condition mentioned in subsection (4) (a) above only if the descriptions of the prisoner's mental disorder by each of the medical practitioners mentioned in subsection (2) above specifies, by reference to the appropriate paragraph (or paragraphs) of the definition of "mental disorder" in section 328(1) of this Act, at least one type of mental disorder that the prisoner has that is also specified by the other.
- (8) A transfer for treatment direction—
 - (a) shall specify, by reference to the appropriate paragraph (or paragraphs) of the definition of "mental disorder" in section 328(1) of this Act, the type (or types) of mental disorder that each of the medical practitioners mentioned in subsection (2) above specifies that the prisoner has that is also specified by the other; and
 - (b) may include such directions as the Scottish Ministers think fit for the removal of the prisoner to, and the detention of the prisoner in, a place of safety pending the prisoner's admission to the specified hospital.
- (9) In subsection (1) above, the reference to a prisoner serving a sentence of imprisonment includes a reference—

CHAPTER 1 S

DUTIES FOLLOWING MAKING OF ORDER

137 Part 9 care plan S

- (1) This section applies where a compulsion order authorising the measures specified in it for the period mentioned in section 57A(2) of the 1995 Act (any such compulsion order being referred to in this Part of this Act as a "relevant compulsion order") is made in respect of a patient.
- (2) As soon as practicable after a patient's responsible medical officer is appointed under section 230 of this Act the responsible medical officer shall—
 - (a) prepare a plan (any such plan being referred to in this Part of this Act as a "Part 9 care plan") relating to the patient; and
 - (b) ensure that the patient's Part 9 care plan is included in the patient's medical records.
- (3) The Part 9 care plan shall record—

CHAPTER 3 S

CONDITIONAL DISCHARGE

230 Appointment of patient's responsible medical officer S

 - (ii) has not been subjected to any undue influence in making the revocation.
- (5) The nomination of a named person shall be effective notwithstanding the nominator's becoming, after making the nomination, incapable.

271A Regulation-making powers S

- (1) A hospital is a "qualifying hospital" for the purposes of sections 268 to 271 of this Act if—
 - (a) it is not a state hospital, and
 - (b) it is specified, or is of a description specified, in regulations.

Advance statements

Advance statements: making and withdrawal S

- (1) An "advance statement" is a statement complying with subsection (2) below and specifying—
 - (a) the ways the person making it wishes to be treated for mental disorder;
 - (b) the ways the person wishes not to be so treated,

in the event of the person's becoming mentally disordered and the person's ability to make decisions about the matters referred to in paragraphs (a) and (b) above being, because of that, significantly impaired.

- (2) An advance statement complies with this subsection if—
 - (a) at the time of making it, the person has the capacity of properly intending the wishes specified in it;
 - (b) it is in writing;
 - (c) it is subscribed by the person making it;
 - (d) that person's subscription of it is witnessed by a person (the "witness") who is within the class of persons prescribed by regulations for the purposes of this paragraph and who signs the statement as a witness to that subscription; and
 - (e) the witness certifies in writing on the document which comprises the statement that, in the witness's opinion, the person making the statement has the capacity referred to in paragraph (a) above.
- (3) An advance statement may be withdrawn by the person who made it by a withdrawal complying with this subsection; and a withdrawal so complies if—
 - (a) at the time of making it the person has the capacity properly to intend to withdraw the statement; and
 - (b) it is made by means of a document which, were it an advance statement, would comply with paragraphs (b) to (e) of subsection (2) above.

276 Advance statements: effect S

- (1) If the Tribunal is satisfied as to the matters set out in subsection (2) below, it shall, in making any decision in respect of a patient who is a person who has made and not withdrawn an advance statement, have regard to the wishes specified in the statement.
- (2) Those matters are—
 - (a) that, because of mental disorder, the ability of the person who made the advance statement to make decisions about the matters referred to in paragraphs (a) and (b) of subsection (1) of section 275 of this Act is significantly impaired;
 - (b) that the statement complies with subsection (2) of that section;
 - (c) that any measures or treatment which might or will be authorised by virtue of the decision referred to in subsection (1) above or might or will, by virtue of that decision, no longer be authorised correspond to any wishes specified in the statement; and
 - (d) that, since the person made the statement, there has been no change of circumstances which, were the person to have been considering making the statement at the time the Tribunal is making the decision referred to in subsection (1) above, would have been likely to cause the person not to make the statement or to make a substantially different one.
- (3) A person giving medical treatment authorised by virtue of this Act or the 1995 Act to a patient who is a person—
 - (a) who has made and not withdrawn an advance statement; and
 - (b) whose ability to make decisions about the matters referred to in paragraphs (a) and (b) of subsection (1) of section 275 of this Act is, because of mental disorder, significantly impaired,

shall have regard to the wishes specified in the advance statement.

then the Tribunal, person having those functions or, as the case may be, designated medical practitioner shall comply with the requirements set out in subsection (8) below.

Duty to mitigate adverse effect of compulsory measures on parental relations

- (1) Subsection (2) below applies—

279 Information for research S

- (1) A person having functions by virtue of this Act shall, on being required to do so by the Scottish Ministers—
 - (a) provide them or any other person specified in the requirement with such relevant information as is so specified; and

- (4) Where provision is made by regulations under paragraph (c) of subsection (1) above, the regulations shall provide for the reception of patients in Scotland to take place only with the consent of the Scottish Ministers.

291 Application to Tribunal in relation to unlawful detention S

Entry to premises

Warrant to enter premises for purposes of taking patient S

- (1) If a sheriff or a justice of the peace is satisfied by an authorised person's evidence on oath as to the matters mentioned in subsection (2) below, the sheriff or, as the case may be, justice of the peace may grant a warrant under this subsection.
- (2) Those matters are—
 - (a) that for the purposes for which the authorised person is authorised it is necessary to enter premises; and
 - (b) that the authorised person—
 - (i) is unable to obtain entry to those premises; or
 - (ii) reasonably apprehends that the authorised person will be unable to obtain entry to those premises.
- (3) A warrant under subsection (1) above is a warrant—
 - (a) authorising—

Removal to place of safety

293 Removal order S

- (1) If, on the application of a relevant mental health officer, a sheriff is satisfied that—
 - (a) a person who is aged 16 years or over has a mental disorder;
 - (b) any of the circumstances mentioned in subsection (2) below apply in respect of that person; and
 - (c) that person is likely to suffer significant harm if not removed to a place of safety,

the sheriff may make an order under this section (any such order being referred to in this Act as a "removal order") in respect of that person.

- (2) The circumstances referred to in subsection (1)(b) above are—
 - (a) that the person is subject, or exposed, to—
 - (i) ill-treatment;
 - (ii) neglect; or
 - (iii) some other deficiency in care or treatment;
 - (b) that, because of the mental disorder, the person's property—
 - (i) is suffering loss or damage; or
 - (ii) is at risk of suffering loss or damage; and
 - (c) that the person is—
 - (i) living alone or without care; and
 - (ii) unable to look after himself or his property or financial affairs.

 - (a) a constable reasonably suspects—

 - (b) to the Court of Session under section 322(2) of this Act, may be made only on one or more of the grounds mentioned in subsection (2) below.
- (2) The grounds referred to in subsection (1) above are—
 - (a) that the Tribunal's decision was based on an error of law;
 - (b) that there has been a procedural impropriety in the conduct of any hearing by the Tribunal on the application;
 - (c) that the Tribunal has acted unreasonably in the exercise of its discretion;
 - (d) that the Tribunal's decision was not supported by the facts found to be established by the Tribunal.
- (3) The Tribunal may be a party to an appeal under section 320(2) or 322(2) and in any appeal from the decision of the sheriff principal under section 321(1).
- (4) The court may, where it considers it appropriate, order the Tribunal to be represented at any hearing of an appeal under section 320(2), 321(1) or 322(2).
- (5) In allowing an appeal under section 320(2), 321(1) or 322(2) of this Act the court—
 - (a) shall set aside the decision of the Tribunal; and
 - (b) shall—
 - (i) if it considers that it can properly do so on the facts found to be established by the Tribunal, substitute its own decision; or
 - (ii) remit the case to the Tribunal for consideration anew.
- (6) If the court remits a case under paragraph (b)(ii) of subsection (5) above, the court may—
 - (a) direct that the Tribunal be differently constituted from when it made the decision; and
 - (b) issue such other directions to the Tribunal about the consideration of the case as it considers appropriate.



MEMBERS OF NCF ETC.

Membership

- 1 (1) NCF is to consist of—
 - (a) the NCF Head, appointed by the Scottish Ministers, and
 - (b) at least 2 other members, appointed by the Scottish Ministers.
 - (2) The Scottish Ministers must, when appointing a person under sub-paragraph (1)(a) or (b), have regard to the recommendation of the selection panel mentioned in paragraph 2(1).

 - (ii) to the safety of any other person; and
 - (d) that the making of a hospital direction in respect of the offender is necessary.
- (4) The matters referred to in subsection (2)(a)(ii) above are—
 - (a) that the hospital proposed by the two medical practitioners mentioned in subsection (2)(a) above is suitable for the purpose of giving the medical treatment mentioned in paragraph (b) of subsection (3) above to the offender; and
 - (b) that, were a hospital direction made, the offender could be admitted to such hospital before the expiry of the period of 7 days beginning with the day on which the direction is made.
- (5) The matters referred to in subsection (2)(b) above are—
 - (a) the mental health officer's report, prepared in accordance with section 59B of this Act, in respect of the offender;
 - (b) all the circumstances, including—
 - (i) the nature of the offence of which the offender was convicted; and
 - (ii) the antecedents of the offender; and
 - (c) any alternative means of dealing with the offender.
- (6) A hospital direction may authorise detention in a state hospital only if, on the written or oral evidence of the two medical practitioners mentioned in subsection (2)(a) above, it appears to the court—
 - (a) that the offender requires to be detained in a state hospital under conditions of special security; and

- (b) that such conditions of special security can be provided only in a state hospital.
- (7) The measures mentioned in subsection (2) above are—
 - (a) in the case of an offender who, when the hospital direction is made, has not been admitted to the specified hospital, the removal, before the expiry of the period of 7 days beginning with the day on which the direction is made, of the offender to the specified hospital by—
 - (i) a constable;
 - (ii) a person employed in, or contracted to provide services in or to, the specified hospital who is authorised by the managers of that hospital to remove persons to hospital for the purposes of this section; or
 - (iii) a specified person;
 - (b) the detention of the offender in the specified hospital; and
 - (c) the giving to the offender, in accordance with Part 16 of the Mental Health (Care and Treatment) (Scotland) Act 2003 (asp 13), of medical treatment.
- (8) The court shall be satisfied as to the condition mentioned in subsection (3) (a) above only if the description of the offender's mental disorder by each of the medical practitioners mentioned in subsection (2)(a) above specifies, by reference to the appropriate paragraph (or paragraphs) of the definition of "mental disorder" in section 328(1) of the Mental Health (Care and Treatment) (Scotland) Act 2003 (asp 13), at least one type of mental disorder that the offender has that is also specified by the other.
- (9) A hospital direction—
 - (a) shall specify, by reference to the appropriate paragraph (or paragraphs) of the definition of "mental disorder" in section 328(1) of the Mental Health (Care and Treatment) (Scotland) Act 2003 (asp 13), the type (or types) of mental disorder that each of the medical practitioners mentioned in subsection (2)(a) above specifies that is also specified by the other; and
 - (b) may include such directions as the court thinks fit for the removal of the offender to, and the detention of the offender in, a place of safety pending the offender's admission to the specified hospital.
- (10) In this section—

"medical treatment" has the same meaning as in section 52D of this Act; and

"specified" means specified in the hospital direction.

59B Hospital direction: mental health officer's report

- (1) This section applies where the court is considering making a hospital direction in relation to an offender under section 59A of this Act.
- (2) If directed to do so by the court, the mental health officer shall—
 - (a) subject to subsection (3) below, interview the offender; and
 - (b) prepare a report in relation to the offender in accordance with subsection (4) below.

 - (d) any other information that the mental health officer considers relevant for the purposes of that section.
- (5) In this section, "carer", "primary", in relation to a carer, and "mental health officer" have the same meanings as in section 57C of this Act.

59C Hospital direction: supplementary

(1) If, before the expiry of the period of 7 days beginning with the day on which a hospital direction is made, it appears to the court, or, as the case may be, the Scottish Ministers, that, by reason of emergency or other special circumstances, it is not reasonably practicable for the offender to be admitted to the hospital specified in the hospital direction, the court, or, as the case may be, the Scottish Ministers, may direct that the offender be admitted to such other hospital as is specified.

(2) Where—

- (a) the court makes a direction under subsection (1) above, it shall inform the person having custody of the offender; and
- (b) the Scottish Ministers make such a direction, they shall inform—
 - (i) the court; and
 - (ii) the person having custody of the offender.
- (3) Where a direction is made under subsection (1) above, the hospital direction shall have effect as if the hospital specified in the hospital direction were the hospital specified by the court, or, as the case may be, the Scottish Ministers, under subsection (1) above.
- (4) In this section, "court" means the court which made the hospital direction.".
