43 **[^{F2}Effect of emergency detention certificate on certain orders]**

- (1) This section applies where—
- a patient is subject to a [^{F3}relevant order]; and
 - an emergency detention certificate is granted in respect of the patient.
- (2) [^{F4}A relevant order] shall, subject to subsection (3) below, cease to authorise the measures specified in it for the period during which the patient is subject to the emergency detention certificate.
- (3) If the measure mentioned in section 66(1)(b) of this Act [^{F5}or (as the case may be) section 57A(8)(b) of the 1995 Act] is specified in the [^{F6}relevant order], the [^{F6}relevant order] shall continue to authorise that measure during the period mentioned in subsection (2) above.
- [^{F7}(4) In this section, the references to a relevant order are to—
- a compulsion order, or
 - a compulsory treatment order or an interim compulsory treatment order.]
