SHORT-TERM DETENTION

Duties on hospital managers

46 Hospital managers' duties: notification

- (1) This section applies where a patient is [^{F1}subject to] a short-term detention certificate.
- (2) The managers of the hospital shall as soon as practicable after the production to them of the short-term detention certificate, give notice of its granting to—
 - (a) the patient;
 - (b) the patient's named person;
 - (c) any guardian of the patient; and
 - (d) any welfare attorney of the patient.
- (3) The managers of the hospital shall, before the expiry of the period of 7 days beginning with the day on which the certificate is granted, give notice of its granting ^{F2}... to—
 - (a) the Tribunal; and
 - (b) the Commission.
- [^{F3}(4) When giving notice under subsection (2) or (3) above, the managers of the hospital are to send a copy of the certificate to each recipient of the notice.]
