Revocation of supervision requirement

36 [F1Revocation of compulsory supervision order on making of adoption order]

- (1) Subsection (2) applies where—
- (a) the child to be adopted is subject to a [F2compulsory supervision order], and
 - (b) the appropriate court is satisfied that, were it to make an adoption order in relation to the child, [F3it would no longer be necessary that, for the protection, guidance, treatment or control of the child, the child be subject to the compulsory supervision order.]
- (2) The court must make an order providing that, on the making of the adoption order, the [F4compulsory supervision order] ceases to have effect.
