# [FITHE COMMISSIONER FOR ETHICAL STANDARDS IN PUBLIC LIFE IN SCOTLAND]

#### **Finance**

## 21 Funding

- (1) The Parliamentary corporation is to—
  - (a) pay the remuneration and allowances of [F1the] Commissioner,
  - (b) pay any expenses properly incurred by the [F2Commissioner] in the performance of [F3the Commissioner's] functions, so far as not met out of sums received and applied by [F4the Commissioner] under section 12(5),
  - (c) indemnify the F5... Commissioner in respect of any liabilities incurred by [F6the] Commissioner in the performance of [F7the] Commissioner's functions.
- (2) Subsection (1)(b) does not require the Parliamentary corporation to pay any expenses incurred by the [F8Commissioner] which exceed or are otherwise not covered by a budget or, as the case may be, a revised budget approved under section 20.
- (3) However, the Parliamentary corporation may pay those expenses.
