[FITHE COMMISSIONER FOR ETHICAL STANDARDS IN PUBLIC LIFE IN SCOTLAND]

Finance

19 Accountable officer

- (1) The Parliamentary corporation must designate [F1the Commissioner] or a member of the [F2Commissioner's] staff as the accountable officer for the purposes of this section.
- (2) The functions of the accountable officer are—
 - (a) signing the accounts of the expenditure and receipts of the [F3Commissioner],
 - (b) ensuring the propriety and regularity of the finances of the [F3Commissioner],
 - (c) ensuring that the resources of the [F3Commissioner] are used economically, efficiently and effectively, and
 - (d) the duty in subsection (3).
- (3) Where the accountable officer[F4 is not the Commissioner and] is required to act in some way but considers that to do so would be inconsistent with the proper performance of a function set out in subsection (2)(a) to (c), the accountable officer must—
 - (a) obtain written authority from the [F5Commissioner] before taking the action, and
 - (b) as soon as possible, send a copy of the authority to the Auditor General for Scotland.
- (4) The accountable officer is answerable to the Parliament for the performance of the functions in subsection (2).

20 Budget

- (1) The [F6Commissioner] must, before the start of each financial year, prepare proposals for [F7the Commissioner's] use of resources and expenditure during the year (a "budget") and, by such date as the Parliamentary corporation determines, send the budget to the Parliamentary corporation for approval.
- (2) The [F8Commissioner] may, in the course of a financial year, prepare a revised budget for the remainder of the year and send it to the Parliamentary corporation for approval.
- (3) In preparing a budget or a revised budget, the [F9Commissioner] must ensure that the resources of the [F9Commissioner] will be used economically, efficiently and effectively.
- (4) A budget or revised budget must contain a statement that the [F10Commissioner] has complied with the duty under subsection (3).

21 Funding

- (1) The Parliamentary corporation is to—
 - (a) pay the remuneration and allowances of [F11the] Commissioner,

- (b) pay any expenses properly incurred by the [F12Commissioner] in the performance of [F13the Commissioner's] functions, so far as not met out of sums received and applied by [F14the Commissioner] under section 12(5),
- (c) indemnify the F15... Commissioner in respect of any liabilities incurred by [F16the] Commissioner in the performance of [F17the] Commissioner's functions.
- (2) Subsection (1)(b) does not require the Parliamentary corporation to pay any expenses incurred by the [F18Commissioner] which exceed or are otherwise not covered by a budget or, as the case may be, a revised budget approved under section 20.
- (3) However, the Parliamentary corporation may pay those expenses.

22 Accounts and audit

- (1) The [F19Commissioner] must, in accordance with any directions in that regard given by the Scottish Ministers—
 - (a) keep proper accounts and accounting records,
 - (b) prepare annual accounts in respect of each financial year, and
 - (c) send a copy of the annual accounts to the Auditor General for Scotland for auditing.
- (2) If requested by any person, the [F19Commissioner] must make the audited accounts available, at any reasonable time, without charge and in printed or electronic form, so that they may be inspected by that person.
