## PART 1

### [<sup>F1</sup>THE COMMISSIONER FOR ETHICAL STANDARDS IN PUBLIC LIFE IN SCOTLAND]

#### *Finance*

#### 21 Funding

- (1) The Parliamentary corporation is to—
  - (a) pay the remuneration and allowances of [<sup>F1</sup>the] Commissioner,
  - (b) pay any expenses properly incurred by the [<sup>F2</sup>Commissioner] in the performance of [<sup>F3</sup>the Commissioner's] functions, so far as not met out of sums received and applied by [<sup>F4</sup>the Commissioner] under section 12(5),
  - (c) indemnify the <sup>F5</sup>... Commissioner in respect of any liabilities incurred by [<sup>F6</sup>the] Commissioner in the performance of [<sup>F7</sup>the] Commissioner's functions.
- (2) Subsection (1)(b) does not require the Parliamentary corporation to pay any expenses incurred by the [<sup>F8</sup>Commissioner] which exceed or are otherwise not covered by a budget or, as the case may be, a revised budget approved under section 20.
- (3) However, the Parliamentary corporation may pay those expenses.
