The Police Act 1997(c. 50)

- 9.—(1) Section 119B (independent monitor) is amended as follows.
- (2) Omit subsection (5)(a).
- (3) In subsection (5)(c) omit the words from “or disclosed” to the end.
- (4) After subsection (5)(c) insert—
- “(ca) a sample of cases in which the chief officer of a police force has decided that information should be disclosed or not disclosed to the Department for the purpose of the provision by the Department of update information under section 116A;”.
- (5) After subsection (8) insert—
- “(8A) The independent monitor has the functions conferred on the monitor by section 117A.”.
- (6) In subsection (9) after “section” insert “ or section 117A ”.
