**Title and commencement**

**1.**—(1) This Order may be cited as the Criminal Justice (Confiscation) (Northern Ireland) Order 1990.

**37.**—(1) The Police and Criminal Evidence (Northern Ireland) Order 1989 shall be amended as follows.
