The Police (Northern Ireland) Act 2000 (Commencement No. 3 and Transitional Provisions) Order 2001

Made - - - 29th October 2001

The Secretary of State, in exercise of the powers conferred on him by section 79 of the Police (Northern Ireland) Act 2000(1), hereby makes the following Order:

**1.** This Order may be cited as the Police (Northern Ireland) Act 2000 (Commencement No. 3 and Transitional Provisions) Order 2001.

**2.** The provisions of the Police (Northern Ireland) Act 2000 specified in the Schedule to this Order shall come into operation on 4th November 2001.

**3.** Section 57 of the Police (Northern Ireland) Act 2000 does not require the Board to issue a report relating to a period before section 2 of the Act comes into force.
