Accordingly, Her Majesty is pleased, by and with the advice of Her Privy Council, to order as follows:

Citation and commencement

1. This Order may be cited as the Scottish Parliament (Disqualification) Order 2015 and comes into force on the day after the day on which it is made.

An office-holder of a description specified in column 1 of Part 2 of the Schedule is disqualified from being a member of the Scottish Parliament for any constituency specified in relation to that office-holder in column 2 of that Part of the Schedule and for any region specified in relation to that office-holder in column 3 of that Part of the Schedule.

4. The Scottish Parliament (Disqualification) Order 2010(3) is revoked.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order specifies the office holders who are disqualified from being a member of the Scottish Parliament. Part 1 of the Schedule specifies the office-holders who are disqualified from being a member of the Parliament and Part 2 of the Schedule specifies the office-holders who are disqualified from being a member of the Parliament but only for particular constituencies or regions.

The Order revokes and replaces the Scottish Parliament (Disqualification) Order 2010.
