Present,

The Queen's Most Excellent Majesty in Council

This Order is made in exercise of the powers conferred by section 15(1) and (2) of the Scotland Act 1998<sup>(1)</sup>, and all other powers enabling Her Majesty to do so.

In accordance with section 115(1) and paragraphs 1 and 2 of schedule 7 of that Act, a draft of this instrument has been laid before and approved by resolution of the Scottish Parliament<sup>(2)</sup>.

Accordingly, Her Majesty is pleased, by and with the advice of Her Privy Council, to order as follows:

**Citation and commencement**

1. This Order may be cited as the Scottish Parliament (Disqualification) Order 2020 and comes into force on the day after the day on which it is made.

**Specified office-holders**

2. An office-holder of a description specified in Part 1 of the schedule is disqualified from being a member of the Scottish Parliament.

3. An office-holder of a description specified in column 1 of Part 2 of the schedule is disqualified from being a member of the Scottish Parliament for any constituency specified in relation to that
