**The Criminal Proceedings etc. (Reform) (Scotland)  
Act 2007 (Commencement No. 8) Order 2009**

*Made - - - - 1st December 2009*

The Scottish Ministers make the following Order in exercise of the powers conferred by section 84(1) and (2) of the Criminal Proceedings etc. (Reform) (Scotland) Act 2007<sup>(1)</sup>.

**Citation**

1. This Order may be cited as the Criminal Proceedings etc. (Reform) (Scotland) Act 2007 (Commencement No. 8) Order 2009.

**Interpretation**

2. In this Order—

“the 2007 Act” means the Criminal Proceedings etc. (Reform) (Scotland) Act 2007; and

“the 1995 Act” means the Criminal Procedure (Scotland) Act 1995<sup>(2)</sup>.

**Commencement**

3.—(1) The provisions of the 2007 Act specified in column 1 of Schedule 1, the subject matter being specified in column 2, come into force on 14th December 2009.

(2) The provisions of the 2007 Act specified in column 1 of Schedule 2, the subject matter being specified in column 2, come into force on 22nd February 2010.

(3) The coming into force of the provisions listed in Schedules 1 and 2 are subject to any exceptions or limitations on extent specified in those Schedules.

(4) Where a particular purpose or area is specified in relation to any provision in column 1 of Schedule 1 or 2, that provision shall come into force, on 14th December 2009 or 22nd February 2010 as the case may be, for that purpose or in that area only.

## EXPLANATORY NOTE

*(This note is not part of the Order)*

The Criminal Proceedings etc. (Reform) (Scotland) Act 2007 (“the 2007 Act”) received Royal Assent on 22nd February 2007.

Article 3(1) of, and Schedule 1 to, this Order bring into force various provisions of the 2007 Act, which will apply to the Sheriffdom of North Strathclyde from 14th December 2009. The provisions coming into force on that date together with the relevant subject matter are listed in Schedule 1 to the Order.

Article 3(2) of, and Schedule 2 to, this Order bring various provisions of the 2007 Act fully into force throughout Scotland on 22nd February 2010.

*Status: This is the original version (as it was originally made). This item of legislation is currently only available in its original format.*

The provisions commenced by this Order go hand-in-hand with the establishment of justice of the peace courts (“JP courts”) (and the associated disestablishment of district courts) in the Sheriffdoms of North Strathclyde and South Strathclyde, Dumfries and Galloway. The Justice of the Peace Courts (Sheriffdom of North Strathclyde) etc. Order 2009 ([S.S.I. 2009/331](#)) (as amended by the Justice of the Peace Courts (Sheriffdom of North Strathclyde) etc. Amendment Order 2009 ([S.S.I. 2009/409](#))) and the Justice of the Peace Courts (Sheriffdom of South Strathclyde, Dumfries and Galloway) etc. Order 2009 ([S.S.I. 2009/332](#)) make provision as to the establishment and disestablishment of those courts.

The Justice of the Peace Courts (Sheriffdom of Lothian and Borders) etc. Order 2008 ([S.S.I. 2008/31](#)) made provision in relation to the establishment of JP courts in the Sheriffdom of Lothian and Borders on 10th March 2008. The Justice of the Peace Courts (Sheriffdom of Grampian, Highland and Islands) Order 2008 ([S.S.I. 2008/93](#)) (as amended by the Justice of the Peace Courts (Sheriffdom of Grampian, Highland and Islands) Amendment Order 2008 ([S.S.I. 2008/179](#))) made provision in relation to the establishment of JP courts in the Sheriffdom of Grampian, Highland and Islands on 2nd June 2008.
