An Act to make provision as respects the performance of unpaid work by persons convicted or placed on probation in Scotland; and for connected purposes [31st July 1978]

Grants in respect of community service facilities.

After section 27 of the MI Social Work (Scotland) Act 1968 there shall be inserted the following section—

"27A Grants in respect of Community service facilities.

The Secretary of State may make to a local authority grants of such amount and subject to such conditions as he may with the consent of the Treasury determine in respect of expenditure incurred by the authority in providing a service for the purposes mentioned in paragraph (b) of section 27(1) of this Act in relation to persons mentioned in sub-paragraph (iii) of that paragraph.".

- 1 In section 27 (supervision of persons put on probation or released from prisons etc.)
 - (a) at the end of subsection (1)(b)(ii) add "and (iii) without prejudice to sub-paragraphs (i) and (ii) above, persons in the area who are subject to a community service order under the Community Service by Offenders (Scotland) Act 1978 or a probation order which includes a requirement that the offender shall perform unpaid work";
 - (b) for the words "probation scheme" wherever they occur substitute "probation and community service scheme".
