



# Town and Country Planning Act 1990

## 1990 CHAPTER 8

### PART XIV

#### FINANCIAL PROVISIONS

#### **[<sup>F1</sup>303 Fees for planning applications etc.**

- (1) The appropriate authority may by regulations make provision for the payment of a fee or charge to a local planning authority in respect of—
- the performance by the local planning authority of any function they have;
  - anything done by them which is calculated to facilitate or is conducive or incidental to the performance of any such function.

#### **[<sup>F2</sup>(1ZA) The Secretary of State may by regulations make provision for the payment of a fee to—**

- the Mayor of London in respect of an application for consent, agreement or approval as mentioned in section 61DB(2) or the giving of advice about such an application;
- a specified person in respect of an application for consent, agreement or approval for which provision is made under section 61DB(4) or the giving of advice about such an application.]

#### **[<sup>F3</sup>(1A) The Secretary of State may by regulations make provision for the payment of a fee to the Secretary of State in respect of—**

- any application made to the Secretary of State under section 62A;
- the giving of advice about applying under section 62A for any permission, approval or consent or for anything else for which an application may be made under that section.]

#### **[<sup>F4</sup>(1B) The Welsh Ministers may by regulations make provision for the payment of a fee or charge to the Welsh Ministers in respect of—**

- the performance by the Welsh Ministers of any function they have in respect of an application under section 62D (developments of national significance), section 62M (option to make application directly to Welsh Ministers) or section 62O (connected applications);

- (b) anything done by the Welsh Ministers which is calculated to facilitate, or is conducive or incidental to, the performance of any such function.
- (1C) References in subsection (1B) to functions that the Welsh Ministers have in respect of an application include references—
- (a) in the case of an application under section 62D, to any functions that the Welsh Ministers have in respect of a secondary consent to which, by virtue of the connection between the consent and the application under section 62D, section 62F(2) applies;
  - (b) to any functions that the Welsh Ministers have, by virtue of provision under section 61Z1, in respect of an application proposed to be made to the Welsh Ministers under section 62D, 62F, 62M or 62O.]
- (2) The appropriate authority may by regulations make provision for the payment of a fee to the appropriate authority or the local planning authority (or of fees to both the appropriate authority and the local planning authority) in respect of any application for planning permission deemed to be made under section 177(5).
- (3) The appropriate authority may by regulations make provision for the payment of a fee to the appropriate authority in respect of any application for planning permission which is deemed to be made to the appropriate authority under—
- (a) any provision of this Act other than section 177(5), or
  - (b) any order or regulations made under this Act.
- (4) The [F5appropriate authority][F5Welsh Ministers] may by regulations make provision for the payment of a fee to the [F5appropriate authority][F5Welsh Ministers] in respect of an application for planning permission [F6or permission in principle] made under section 293A (urgent Crown development).
- [F7(4A) The Secretary of State may by regulations make provision for the payment of a fee to the Secretary of State in respect of an application under section 293B, 293D or 293E.]
- (5) Regulations under this section may in particular—
- (a) make provision as to when a fee or charge payable under the regulations is to be paid;
  - (b) make provision as to who is to pay a fee or charge payable under the regulations;
  - (c) make provision as to how a fee or charge payable under the regulations is to be calculated (including who is to make the calculation);
  - (d) prescribe circumstances in which a fee or charge payable under the regulations is to be remitted or refunded (wholly or in part);
  - (e) prescribe circumstances in which no fee or charge is to be paid;
  - (f) make provision as to the effect of paying or failing to pay a fee or charge in accordance with the regulations;
  - (g) prescribe circumstances in which a fee or charge payable under the regulations to one local planning authority is to be transferred to another local planning authority.
- (6) Regulations under this section may—
- F8(a) .....
  - (b) in the case of regulations made by virtue of subsection (5)(f) or paragraph (a) of this subsection, amend, repeal or revoke any provision made by or under this Act or by or under any other Act.

(7) In this section “the appropriate authority” means—

- (a) the Secretary of State in relation to England;
- (b) the Welsh Ministers in relation to Wales.

(8) No regulations shall be made under this section [<sup>F9</sup>by the Secretary of State] unless a draft of the regulations has been laid before and approved by resolution of—

- (a) each House of Parliament<sup>F10</sup> ...

[<sup>F11</sup>(8A) If a draft of regulations of the Secretary of State under this section would, apart from this subsection, be treated as a hybrid instrument for the purposes of the standing orders of either House of Parliament, it is to proceed in that House as if it were not a hybrid instrument.]

(10) If a local planning authority calculate the amount of fees or charges in pursuance of provision made by regulations under subsection (1) the authority must secure that, taking one financial year with another, the income from the fees or charges does not exceed the cost of performing the function or doing the thing (as the case may be).

(11) A financial year is the period of 12 months beginning with 1 April.]

- (1) The appropriate authority may by regulations make provision for the payment of a fee to the appropriate authority in respect of an appeal to the appropriate authority under any provision made by or under—
  - (a) this Act;
  - (b) the Planning (Listed Buildings and Conservation Areas) Act 1990.
- (2) The regulations may in particular—
  - (a) make provision as to when a fee payable under the regulations is to be paid;
  - (b) make provision as to how such a fee is to be calculated (including who is to make the calculation);
  - (c) prescribe circumstances in which such a fee is to be remitted or refunded (wholly or in part);
  - (d) prescribe circumstances in which no fee is to be paid;
  - (e) make provision as to the effect of paying or failing to pay a fee in accordance with the regulations.
- (3) A fee payable to the appropriate authority under regulations made under this section is payable—
  - (a) by the appellant;
  - (b) in addition to any fee payable to the appropriate authority under regulations made under section 303.

### **[<sup>F18</sup>303A Responsibility of local planning authorities for costs of holding certain inquiries etc.**

[<sup>F19</sup>(1) This section applies if the appropriate authority appoints a person to carry out or hold a qualifying procedure.

(1A) A qualifying procedure is—

- (a) an independent examination under section 20<sup>F20</sup>, 21(5)(b), 27(3)(a)] or 64 of the Planning and Compulsory Purchase Act 2004;
- (b) a local inquiry or other hearing under paragraph 8(1)(a) of Schedule 7;
- (c) the consideration of objections under paragraph 8(1)(b) of that Schedule.

(1B) [<sup>F21</sup>Where a local planning authority cause a qualifying procedure to be carried out or held, the] appropriate authority is—

- (a) the Secretary of State if the local planning authority causing the procedure to be carried out or held is in England;
- (b) the National Assembly for Wales if the local planning authority causing the procedure to be carried out or held is in Wales.]

[ Where the qualifying procedure is an independent examination of a strategic  
<sup>F22</sup>(1C) development plan under section 64 of the Planning and Compulsory Purchase Act 2004, the appropriate authority is the Welsh Ministers.]

- (2) The [<sup>F23</sup>appropriate authority] may require the whole or any part of the costs borne by [<sup>F24</sup>it] in relation to the qualifying [<sup>F25</sup>procedure] to be paid by the local planning authority [<sup>F26</sup>or corporate joint committee] causing the qualifying [<sup>F25</sup>procedure] to be held.
- (3) The [<sup>F23</sup>appropriate authority] may cause the amount of any such costs to be certified; and any amount so certified and required by [<sup>F24</sup>it] to be paid by a local planning authority [<sup>F27</sup>or corporate joint committee] shall be recoverable from that authority [<sup>F28</sup>or committee] as a civil debt.
- (4) What may be recovered under this section by the [<sup>F23</sup>appropriate authority] is the entire administrative cost of, or incidental to, the qualifying [<sup>F25</sup>procedure] , so far as borne by [<sup>F24</sup>it] , including, in particular, such reasonable amount or element as [<sup>F29</sup>it] may determine in respect of the general staff costs and overheads of his department.
- (5) For the purposes of subsection (4), the [<sup>F23</sup>appropriate authority] may by regulations prescribe a standard daily amount in relation to any description of qualifying [<sup>F25</sup>procedure] and any description of person appointed to hold it, <sup>F30</sup> . . . and where, in relation to a qualifying [<sup>F25</sup>procedure] of that description, a person of that description is or has been so appointed, what may be recovered in respect of that qualifying [<sup>F25</sup>procedure] by virtue of the appointment of that person <sup>F30</sup> . . . is—
  - (a) the prescribed standard amount from time to time applicable in the case of that qualifying [<sup>F25</sup>procedure] and that person in respect of each day, or an appropriate proportion of that amount in respect of a part of a day, on which

- that person is engaged in the holding of, or is otherwise engaged on work connected with, the qualifying [<sup>F25</sup>procedure] ;
- (b) any costs actually incurred on travelling or subsistence allowances payable to that person in connection with the qualifying [<sup>F25</sup>procedure] ;
- (c) any costs attributable to the appointment of an assessor to assist that person <sup>F31</sup> . . . and
- (d) any other costs attributable to the appointment of that person.

### 307 Assistance for acquisition of property where objection made to blight notice in certain cases.

**308 Recovery from acquiring authorities of sums paid by way of compensation.**

- (1) This section applies where—
  - (a) an interest in land is compulsorily acquired or is sold to an authority possessing compulsory purchase powers, and

### 310 Sums recoverable from acquiring authorities reckonable for purposes of grant.

Where—
