- (1) Without prejudice to section 245D of this Act, where a person F3... is convicted of an offence [F4punishable by imprisonment] (other than an offence the sentence for which is fixed by law) the court, F5... may [F6, instead of imposing on him a sentence of, or including, imprisonment or any other form of detention,] make an order under this section (in this Act referred to as a "restriction of liberty order") in respect of him.  - (3) A restriction of liberty order may be made for any period up to 12 months.
