



# Special Immigration Appeals Commission Act 1997

1997 CHAPTER 68

[<sup>F1</sup>2B

A person may appeal to the Special Immigration Appeals Commission against a decision to make an order under section 40 of the British Nationality Act 1981 (c. 61) (deprivation of citizenship) if he is not entitled to appeal under section 40A(1) of that Act because of a certificate under section 40A(2) [<sup>F2</sup>(and section 40A(3)(a) shall have effect in relation to appeals under this section).]
