- 7 (1) If [^{F2}Boundaries Scotland] intend to consider making a report under this Schedule—
- (a) [^{F3}it] must inform [^{F4}the Scottish Ministers] by notice in writing;
 - (b) [^{F5}it] must publish a copy of the notice in the Edinburgh Gazette.
- [^{F6}(2) If [^{F7}Boundaries Scotland][^{F8}has] provisionally determined to make recommendations affecting a constituency [^{F9}it] must publish in [^{F10}such manner as it thinks fit] a notice stating—
- (a) the effect of the proposed recommendations and (except if the effect is that no alteration should be made in respect of the constituency) that a copy of the recommendations is open to inspection at a specified place in the constituency, and
 - (b) that representations with respect to the proposed recommendations may be made to the [^{F11}Boundaries Scotland] before the end of the period of one month starting the day after the notice is published.]
- (3) [^{F12}Boundaries Scotland] must take into account any representations made in accordance with the notice.
- (4) If [^{F13}Boundaries Scotland] revise any proposed [^{F13}recommendations] after publishing notice of them under sub-paragraph (2) [^{F14}it] must comply again with sub-paragraphs (2) and (3) in relation to the revised recommendations as if no earlier notice had been published.
